







The application received after due date will not be entertained.

1. A complete set of bidding documents containing detailed terms and conditions may be purchased by interested eligible bidders/firms by writing an application on original letter head from the office of DD/EE office Shigar. The said application must be accompanied by the following documents:
 - PEC valid registration certificate for 2021-22
 - CNIC of the perspective bidders
 - Bid security as specified in shape of CDR/TDR from any scheduled bank mentioning the name of work & title of firm.
 - Renewal fee slip of current financial year 2021-22 of PWD.
 - Bank statement showing closing balance of at least 20% of the value of the project dully verified by concern bank.
 - Certificate of relevant experience of works already successfully completed by the firm dully verified by concern department is required.
 - Power of attorney will not be accepted.
2. Contractors are black listed or having sick/ or slow progress projects will not be eligible to participate.
3. The procuring agency may reject all bids or any one at any time prior to the acceptance of proposals under the provision of PPRA rules.
4. Since the above work involves installation of solar pump works and construction of civil works therefore both PEC relevant code of solar work and civil work is mandatory to participate in the bidding process.
