The applications shall be scrutinized and the tender documents will only be issued to the firms / contractors who have sufficient experience in the relevant-field and satisfy other special conditions required for the job and area. The sealed tenders will be received in the office of accepting officer by 13 Apr 2022 till 1130 hours and will be opened at 1200 hours on the same date.

Note: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

- All contractors will certify in writing that they are registered with Pakistan Engineer Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.
- Firms / Contractors not borne on approved list of MES will furnish their applications along with statement of previous experience, giving details of works executed during last two years and those in hand, on proforma appended below:-
