FINANCIAL YEAR: 2022-23

1. Quotations are invited from the sales tax registered firms for purchase of local purchase medicines (Daily LP) for financial year 2022-2023 from different authorized retailers / distributors in possession of valid license for selling of medicines.
2. Quotations must clearly mention rebate rate.
3. Quotations are invited for provisioning of medicines on daily basis (Daily LP) at PAC Hospital Kamra on supplier's own arrangement.

STANDARD / SPECIAL CONDITIONS FOR PROVISION OF DAILY LP MEDICINES

- Medicines / Items must be registered in accordance with the Drug Act, 1976.
- Medicines / items received must be of reputable / well known firms.
- Medicines / items must be of latest production and batch certificate of same will be provided by supplier.
- LP items are to be supplied at PAC Hospital by the contractor within 4-6 hrs of issue of demand by PAC Hospital.
- The supplier will supply medicines against purchase order on daily basis with maximum shelf life and shall replace free of cost, stock of those medicines whose shelf life is about to expire.
- The supplier is to maintain the already established retail Pharmacy besides PAC Hospital. The pharmacy will function 24/7 and will remain open on all gazetted holidays.
- Supplier is to ensure timely payment of rent and allied charges including rent, utility bills of Gas, Electricity etc.
- The supplier shall hire a qualified Pharmacist and sufficient staff to ensure quality services.
- Supplier is to establish and maintain Bench Stock of medicines.
- Individual packing of the LP items provided to PAC Hospital must be stamped with the words "**PAC Hospital use only**" by the supplier.
- Purchase of cost effective and good quality medicines / surgical and disposable items must be ensured by supplier at all levels.
- 05 years of experience with Armed Forces of Pakistan and performance certificate of same must be provided.
- Payment will be made as per PAC Board procedures.
- All bidding firms will provide GST, NTN and professional Tax registration certificate.

4. Sealed Technical & Commercial quotations with the title "**Tender for purchase of Daily LP Medicines**" must be submitted to the undersigned on **14 April, 2022** up to **1100 Hrs** positively. Bank Draft (CDR) amounting to Rs. 2,800,000/- in the name of undersigned is to be deposited as security in case of acceptance of the offer. Tender would be opened at **1130 Hrs** on the same date.
