Sealed Tenders are hereby invited on percentage rate basis from approved Government Contractors enlisted in respective class and category, limit and in possession of valid renewal from Pak, PWD/PEC for current financial year **2021-22**. The Tender application with documents as per terms and conditions below will be received at least by **21/03/2022** during office hours. After verification of documents, tenders will be issued to the firms fulfilling the terms and conditions below by **24-03-2022** and will be received back duly filled on **25-03-22 at 10:30 am**, and will be opened on the same date at **11:00 am** in the office of the Executive Engineer, Central Civil Division, Pak. P.W.D. Abbottabad in the presence of the eligible firm/contractors or their authorized representatives, who care to be present there.

Terms and Conditions

1. No Tender will be sold by post/telegraphically or through Email on the date of opening of Tenders.
2. Application for issuance of tender (separate for each work) on the original company pad of the contractor /firm duly signed with date, may be submitted at the office of the undersigned on production of CDR equal to **3% of the estimated cost from** the company's owned account after payment of Tender cost (which is nonrefundable).
3. The application should accompany attested copies of CNIC, Certificate showing class and category having renewal of the firm / contractor with Pak.P.W.D/Pakistan Engineering Council for the current year 2021-22. Furthermore tenders will only be issued to the owner of the firm or his authorized representative having legal power of attorney for his work ,general power of attorney is not acceptable.
4. The Firm/Contractor should also furnish attested copies of certificate showing his registration with Income Tax department (NTN No.)/ATL and partnership deed in case of partnership or affidavit declaring himself sole proprietor of the firm, whichever is applicable.
5. Tenders will be issued to firms having at least one completion certificate of the similar nature of work in last 05 years.
6. Tenders in sealed covered envelop shall be received from eligible firms/ contractors along with **differential CDR equal to 5% of Bid Price** from the company's owned account from any schedule bank preferably from Abbottabad in favor of undersigned.
7. Bidders quoting rates below the estimated cost shall have to furnish additional performance security bond of equal amount before commencement of work to avoid further complications.
8. The contractor himself or his representative duly authorized by him should participate in all tender process. The person whose name exists in Form-H / Partnership deed will only be entitled to sign the tender form in case of partnership firm, no proxy will be allowed to participate in the bidding process.
9. The bidder will be required to give a detailed analysis of workability of his bid if deemed necessary.
