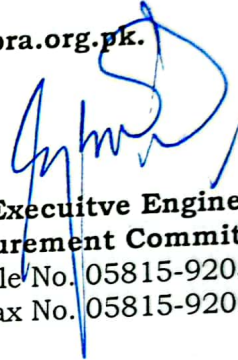

This office intends to recall, the bid for the below mentioned work,

Gilgit-Baltistan Public Work Department (GB PWD) invites sealed bids under QCS method from well-reputed and experienced Consultants registered with income tax department (if applicable) having valid PEC registration (Renewal upto 30th June, 2022) with relevant code. A foreign bidder is entitled to bid only in a joint venture with a Pakistani Consultant in accordance with the relevant provisions of PEC bye-laws for the work mentioned below:-

1. The scope of work shall be consultancy services for Improvement/Widening/Realignment/Pavement design of 112 Km road and Construction of required number of bridges from Burzil Top to Buniyal Shakma Gultari.
2. The Consultants have to undertake the consultancy services as elaborated in the QnE entries.
3. The duration of assignment will be 180 days only, it is expected to be started after issuance of formal letter of acceptance.
4. Method for selection of consultant will be quality and cost based selection (QCS).
5. The Technical bids must be accompanied by a bid Security amounting to **Rs. 0.200 million (Rupees Two lac only)** in shape of call deposit by a scheduled bank of Pakistan in favor of Employer and must be delivered in the office of **The Executive Engineer B&R Division GB PWD Skardu at or before 01:00 pm hours, dated on 12-04-2022 and the bids will be opened on the same date at 01:30 pm**, in the presence of all bidders representatives who may chose to attend at the same address of **The Executive Engineer B&R Division GB PWD Skardu**.
6. The technical bids without call deposit will be summarily rejected being non responsive. Each envelop should be clearly marked as **"Technical bid"** and **"Financial bid"** separately. Technical bids of non-responsive bidders shall be returned un-opened.
7. Technical proposals will be evaluated as per approved criteria that shall be part of bidding document.
8. Financial proposal of only those firm whose technical proposal qualified will be opened in due course of time in presence of qualified consultants / representative who may chose to attend.
9. Weightage for Technical and Financial proposals is 80:20 and minimum being responsiveness the consultant should get at least 75% marks in the technical bid.

10. In case of joint venture, the score of lead partner shall be counted 75% and that associate partner shall be 25%. Both should have to get commutative passing score of 75% or more. More than two partners shall not be allowed.
11. Contract will be signed on PEC bidding documents for lump sum contract with the most advantageous bidder.
12. Eligible Consultant may obtain further information, and purchase the Bidding Documents along with TORs from the **Office of the Employer, Executive Engineer B&R Division GB PWD Skardu (Tel #: 05815-920357) with effect from 04-04-2022 during the office hours.**
13. A complete set of Bidding Documents along with TORs may be purchased by any interested bidder on submission of a written application to the above office upon payment of a non-refundable fee of Rs. 3000/- on Cash payment.
14. Electronic submission of technical and financial bids shall not be allowed.
15. All bidders must fill in self evaluation sheet before submission of bids in their own interest as per section G of the instructions to bidders which shall be a mandatory requirement.
