Sealed bids must be submitted with Pay Order of **PKR 2,000** (Non-Refundable) and **5%** of the bid amount as "bid security" (Refundable to unsuccessful bidder). The bidding shall be carried out on single stage and single envelope basis (Only financial).

TERMS AND CONDITIONS

A-Bidding Process

1- The bidding shall be carried out on single stage single envelope basis (Only financial).

B-Bid Requirements

- 1- Only well-established firms with authorized dealership of Japanese / European brands and registered in tax authorities with valid Sales Tax / NTN Certificate shall participate in bidding process.
- 2- Sealed bids must be submitted in single envelope with Pay Order of **PKR 2,000** (Non-Refundable) as **Tender Fee** in favour of <u>"PEC-PIACL"</u> and 5% of the bid amount as **bid security** (Refundable to unsuccessful bidder) in favour of <u>"PEC-PIACL"</u>.
- 3- All seventeen (17) units should be of the same Model.
- 4- One envelope should contain rates of one model only. If a bidder wants to quote different models / brands, separate envelope with above mentioned pay orders shall be submitted.
- 5- Rates must be quoted in Pak Rupees (Inclusive of all taxes and duties imposed by the Government). Applicable duties / taxes must also be mentioned separately in the proposal. Prices mentioned without GST / applicable taxes will be considered inclusive of same.
- 6- Last date of submission of bids is 13TH April-2022 at 2:00 PM at Precision Engineering Complex-PIA and will be opened on the same day at 3:00 PM in front of the bidders who may choose to be present.

C- Validity of Offer

1- The validity period of the bids must not be less than 90 days.

D-Bid Acceptance

1- Award of purchase order after management's approval shall be issued strictly on the specification / quality of items and not only on the basis of lowest rates.



E- Technical Specifications

F- Delivery

1- A/C Units and accessories must be installed and commissioned within 30 days of issuance of Purchase Order date.

G-Inspection

 Inspection of supplied goods as per given technical specifications shall be carried out at the time of delivery.

H- Risk Purchase

1- In the event of failure on the part of supplier to supply the items on time or supplying below standard item, the item will be purchased at the risk and expense of the supplier and difference of rate will be paid by supplier.





I- Payment Terms

1- Payment will be released after successful execution of the said job as per PIA account policy. 5% of the amount will be withheld as **security deposit for 3 months** to cater for any unforeseen problems.

J- Offer Format

1- Financial Offer is required to be submitted as per attached form.

Non-compliance with any of the terms & conditions will render the bid as non-conforming and shall be rejected.

Decision of the PEC Management Committee will be final & binding to all the participants.
