
2. The tender document(s) can be obtained from Administration Branch, Collectorate of Customs (Exports), PMBQ, Karachi, on cash payment of **Rs. 2,000/- (nonrefundable)** during office hours on or before 11.04.2022.

Terms and Conditions

- The tender shall be granted on the basis of competitive bidding process, as is embodied in Public Procurement Rules, 2004.
- The bidders should be registered with Income Tax and Sales Tax Departments, having their own office & phone/fax numbers (if found contrary, the tender will be rejected).
- The bidders should not have been black-listed by any authority in the past.
- The bidders are required to furnish security deposit of 5% of their offer, in the shape of pay order or demand draft from a scheduled bank in favor of the **Collector, Collectorate of Customs Exports, PMBQ, Karachi**. This Security Deposit shall be refunded to the unsuccessful bidder(s). The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- The price shall be offered in local currency and include all duties/taxes and the expenses incurred on supplies including transportation, labour etc, where required.
- The tender bid must mention the type of warrantee and after sale services, if any.
- Sealed tender bids on prescribed tender document must be delivered to the address given below on **11.04.2022**, before **01:00pm** and the same shall be opened at **01:30pm** on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.

- viii. Bidders shall quote their final prices both in figures and in words, any cutting/overwriting and correction in the tender form will not be accepted.
- ix. Bidders are required to give complete description, catalogue of items along with samples of their offers.
- x. The tender bid must be valid for at least **90 days**, after opening of tenders.
- xi. Payments will be made on the basis of verification / inspection by concerned staff and subsequent report submission.
- xii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.
- xiii. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least ten days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs Exports Custom House Karachi.
