Firms / Contractor, not borne on the approved list of MES Contractor will furnish with their application proof of their being on the appropriate list of the Department concerned, a statement of financial standing with necessary bank certificate, details of staff employed, details of tools and plants and previous experience giving details and type of work, executed in the last two years and in hand on the proforma appended below duly attested by Class-I Gazetted Officer.

Contractors NOT BORNE on MES approved list of contractors or **THOSE SUSPENDED** from the approved list of MES Contractors due to non depositing enhanced amount of standing security will deposit earnest money equal to 2% of the above mentioned estimated cost in the form of FDR, Deposit At Call etc dully pledged in the name of GE (NAVY) MAINT ORMARA. This amount is refundable; if the contractors are not pre-qualified / they do not secure the contract.
