 - Government Departments will be given preference.

- Photocopy of NTN, GST & SST (if applicable)
- Undertaking on Non-judicial stamp paper of Rs.100/- certifying that owner / building is not temporary / permanently debarred from any Government agency / authority / department (without bearing any responsibility on NADRA whatsoever in this regard).
- Fitness Certificate

- Quoted price shall be inclusive of all taxes except GST / SST which shall be mentioned separately (if applicable).
