National Vocational & Technical Training Commission (NAVTC), Government of Pakistan invites sealed proposals through **Single Stage Two Envelope Bidding Procedure** as per Rule-36(b) of PP Rules, 2004 from interested and registered, firms for **"Establishing 75 Smart-TECH laboratories at public Sector Technical & Vocational Education and Training Institutes across Pakistan including Gilgit-Baltistan and Azad Jammu & Kashmir"** under Prime Minister's "Skills for All - Hunarmand Pakistan Program". The description is as under:-

Tender No.1	Development and Provision of LMS,CMS, Trainings and Support Content, Hosting & connectivity and compatibility
Tender No.2	Provision, installation and commissioning of IT Equipment, Hardware, Provision, fixation and commissioning of Furniture & Fixtures, Provision, installation and commissioning of Power Backup Solar UPS System, Civil, Maintenance and Renovation work in labs

2. The interested bidders must be technically sound and registered with respective taxation (with valid NTN and STRN), and other relevant authorities in Pakistan. They should possess authorization from Principal/manufacturer/authorized dealer, of equipment / supplies to be provided under this tender. They shall demonstrate capacity to complete the assignment of establishing Smart-TECH laboratories in TVET sector, equipped with sophisticated IT based training aids, equipment, simulators, interactive software, digital contents, Learning Management System (LMS) and Class Management System (CMS), with provisions for virtual TVET, skill development and distance learning programs/material.
