TENDER NOTICE FOR THE PURCHASE OF "TRAINED SNIFFER DOGS" FOR NARCOTICS, ARMS & EXPLOSIVES AND CURRENCY NOTES DETECTION BY THE COLLECTORATE OF CUSTOMS, JINNAH INTERNATIONAL AIRPORT, KARACHI

Sealed tenders are invited from the agencies/firms of good reputation for supply of "Trained Dogs" required for detection of narcotics substances such as heroin, cocaine, methamphetamine, marijuana hashish (charas), opium and Ecstasy Pills, as well as detecting currency notes and Arms explosives at Collectorate of Customs JIAP, Karachi. The offer may, inter alia, include the following details:

Technical Terms & Condition

- The dog must be a pedigreed Labrador Retriever, Cocker Spaniel, German Shepherd or Belgain Malanois and must have an original pedigree certificate.
- ii. The dog must be trained for detecting narcotics substances such as heroin, cocaine, methamphetamine, marijuana hashish (charas), opium and E (Ecstasy) Pills as well as detecting currency notes and Arms & explosives.
- iii. The dogs must be trained from Pakistan Army Canine Unit or other international and WCO accredited dog training centers.

- iv. The dogs must be of male gender and not more than 9 month old. He should have undergone complete obedience as well as detection training.
- v. The vendor must provide a one-year warranty that covers the canine's health, fitness and detection skills.
- vi. Bidder must provide certify that the dog bears the characteristics at the time of procurement; Confidence, trainability, sociability, athleticism, no Aggression, calmness around people, etc.
- vii. Physical characteristics such as sound and proportionate body, clear eyes and ears, rash free coats, well-formed and sturdy limbs etc. are mandatory requirements.
- viii. All dogs should be micro-chipped for identification.
- ix. Each dog should be certified from an accredited and recognized body and institution in Pakistan in the required training discipline.
- x. The pedigree and age of each dog should be certified from accredited and recognized bodies and institution in Pakistan.
- xi. Each dog should be accompanied with Certificate of Age, Health and Standard Vaccinations from Pakistan Army Canine Unit or other international and WCO accredited dog training centers.
- xii. Before delivery, a committee of experts shall verify the certification documents with the required physical attribute and the quality of training imparted to each sniffer dog. Any sub-standard dog so presented for delivery shall be forthwith rejected by the committee.

GENERAL TERMS & CONDITIONS:

- 1. Bids are to be submitted on Tender Form as per PPRA Rules, 2004 which can be obtained from Administration Branch, Collectorate of Customs JIAP, Air Fright Unit, Air Port, Karachi on payment of Rs: 5000/- (non refundable) per set during the office hours after the publication of this advertisement with immediate effect.
- 2. Tenderers are required to submit their bids comprising of single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and documentary/technical proposal. The envelopes shall be marked as "DOCUMENTARY/TECHNICAL PROPOSAL" & "FINANCIAL PROPOSAL" in bold legible letters and no bidder will be allowed to alter or modify his bid after the opening of the bids.

- 3. Sealed bids must be dropped in the Tender Box placed in the Administration Branch, Air Fright Unit, Collectorate of Customs, Jinnah International Airport, Karachi, on or before 21st April, 2022 upto 1400 hours. The "DOCUMENTRY/TECHNICAL PROPOSAL" will consist of bidders' documentary data including details about the bidders' firm, date of establishment, training facilities and methods, location of kennels and list of supplies to different organizations/govt. agencies along with the soft copy of the kennels and training being carried out by them which will be opened on the same day at 1500 hours in the presence of Tenderers who may like to witness the opening up of sealed tenders whereas the date of opening of "FINANCIAL PROPOSAL" will be announced on the same day.
- 4. The suppliers selected in the "DOCUMENTARY/TECHNICAL PROPOSALS" will be bound to arrange a visit for the members of the purchase committee or the team of experts to their kennels.
- 5. Evaluation criteria shall be based upon the quality/specifications mentioned in the tender notice.
- 6. The bidders are required to submit separately unit price of dog of each category.
- 7. Following documents must be attached with proposal:
 - i. Authority letter showing the details of authorized person alongwith copy of CNIC
 - ii. An affidavit confirming that the company is not black listed anywhere.
- 8. The competent authority reserves the right for rejection/acceptance of any/all of the bids received and the authority may communicate the grounds for its rejection upon request of any supplier who has submitted a bid.
- 9. Successful bidders will be required to pay all taxes as per government rules.
- 10. Conditional bids will not be accepted.
