a. NAB is Pakistan's apex anti-corruption organization charged with the responsibility of elimination of corruption and corrupt practices. It operates under the Provisions of National Accountability Ordinance, 1999 in the country

### 2. Objectives and Procurement Mode

- a. NAB intends to Purchase Hardware and Software Items for financial year 2021-2022.
- b. The contract will be awarded after open competitive bidding as per PPRA rules 36(b) (One stage two envelopes of Public Procurement rules 2004)

#### 3. Terms and Conditions

a.	Reputed firms with valid NTN/GST number should apply.		
b.	The firm(s) should be registered with Income Tax and Sales Tax departments		
c.	The firm(s) should provide a valid vendor number issued from AGPR Office Islamabad.		
d.	Black listed firm need not to apply. Interested bidders must submit a certificate/affidavit regarding status of firm pertaining to black listed or not.		
e.	Tender should accompany (refundable) call deposit @Rs.3% of Tender value in favour of NAB HQ Islamabad.		
f.	The approved firm(s) / successful bidder(s) will be bound to furnish a warranty of items for 01 year / 02 years / 03 years or as the case may be. The approved firm(s) will also provide items within specified time frame from receipt of supply orders at Islamabad. If supply is not made in due time the security amount will be confiscated.		
g.	Bidders shall provide authorization from the Principal committing warranty & maintenance during the warranty period		
h.	The bids will be opened in the presence of bidders or their authorized representative at Main Reception, NAB HQ,G 5/2 old building, Islamabad		
i.	Lowest evaluated bids will be awarded the contract / tender.		
j.	The successful bidder will be bound to supply the items during specific period after the issuance of supply orders at NAB HQ Islamabad.		
k.	The procuring agency (NAB) may reject all bids or proposal at any time prior to their acceptance as per PPRA Rule 2004		
1.	Bids/proposals must contain the complete name and address of bidders and the name, mailing address and telephone numbers of the person designated for coordination with the NAB HQ.

0.	Bids containing false or misleading statement regarding requirement of request will be rejected.		
p.	There shall be no negotiations with the bidders having submitted the lowest evaluated bids or with any other bidders.		
q.	The procuring agency shall keep all information regarding the bid evaluation confidential until the time of the announcement of the evaluation report.		
r.	Failure to comply with the requirements(s) / (TORs) by the bidders may lead the bidders to be non-responsive and may be rejected.

#### 5. Redressal of Grievances

a.	Any bidder aggrieved by any act of the procuring agency after the submission

b.	A grievance redressal committee will be constituted (comprising of odd number of officers) to address complaint of the bidders under the Chairmanship of Addl. Director / Director NAB HQ.		
c.	Mere fact of lodging a complaint shall not warrant suspension of the procurement Process.
