A) SUBMISSIONOF TENDER

The tenders may be dropped in the tender box marked as "Tender Box Commercial Purchases" placed at the entrance of the PIA Supply Chain Management latest by 10:30hours on the specified date. You may also send your tenders through registered A/D mail addressed to GM Contact Management, which must reach before the closing date and time mentioned above. Tenders will be opened at11:00 hours on the same day in the presence of tenderers.
- 2. Tenders received after stipulated date & time shall not be considered. The Corporation will not be responsible for postal delays. The decision of GM Contract Management in this respect shall be final and binding.
- 3. Bidders are required to submit a Pay Order of Rs. 10,000/- (Not Refundable) as tender fee along with Technical Proposal.

B) <u>EARNEST MONEY/BID SECURITY</u> (For Local Bidders Only)

Introduction

Pakistan International Airlines (hereafter refer to as PIACL) is looking for Service Provider to provide Cellular Services to its officials. These services shall include free On & Off Net Calls, On & Off Net SMS and 4G/LTE based Data Packages. Coverage area is across Pakistan. Initial requirement is for approximately 400 users with International roaming facility (on authorization by PIA ICT Department if and when required). Contract term will for three (03) years. The number of users is neither a guarantee nor a capping and shall be considered just for bid value calculation. Billing will be submitted and paid on an actual number of subscribers.

PIACL invites vendors to submit proposals on Single Stage Two Envelop basis, according to the terms and conditions listed throughout this document. This Request for Proposal (RFP) will serve to provide vendors with the requirements, evaluation criteria, and other information required for the **Cellular Services** across Pakistan.

Scope of work

- 1. Service provider to provide uninterrupted services to PIACL officials across Pakistan. Services must be 4G LTE-based and must have downward compatibility to 3G.
- 2. Service Provider shall provide services and quantity to PIAC officials based on per month packages:

- 5. Number Portability shall be the responsibility of the Selected Service Provider who will bear PTA charges in this regard.
- 6. If an authorized subscriber desires to migrate his/her personal number to official number, it would be the responsibility of the Service Provider to arrange the portability through PTA.

General Terms & Conditions

- a) Incomplete and conditional responses will not be entertained.
- b) PIACL reserves the right to accept/reject wholly or partially any response or cancel the tender process altogether at any stage without assigning any reason.
- c) Responses are liable to be rejected if; they are not conforming to the terms, conditions and specifications stipulated in this document.
- d) Responses submitted via email or fax will not be entertained

- a) PIACL reserves the right to terminate the process without awarding the contract.

BID EVALUATION

The responses will be evaluated as per requirements mentioned in Evaluation Criteria Section of this RFP. For qualifying, bidders shall fulfill all the requirements as laid out in Section "Mandatory Requirements" of Evaluation Criteria. If any of the mandatory requirements is not met by the bidder, the bid will be canceled straightaway and no further consideration will be given. Moreover, bidders will have to secure 65% marks in the Section "Technical Requirement". Scoring less than 65% will disqualify the bid. Weightage of financial bid is 70% and technical bid is 30%. Contract will be awarded on total weightage factor of technical and financial proposals which is 30%-70% respectively.

TERMS OF PAYMENT

- a) Payment shall be released after delivery of services in accordance with the requirements of this agreement and up to the satisfaction of Company within 45 days after the submission of invoice and relevant documents. Payments will be made in Pak Rupees on quarterly basis. No advance payment shall be made.
- b) All payments shall be subject to any and all taxes, duties and levies applicable under the laws of Pakistan for the whole period starting from issuance of Acceptance Letter i.e. till termination of the signed agreement in this regard. These payments may be subjected to deductions of any amount payable by the Service Provider to the Company, including but not limited to damages etc.
