- Renewal receipt GB-PWD for CFY (2021-22).
- No Sick Project in hand (will conformed from Works Secretariat)/affidavit by the contractor. iv.
- CNIC of the Prospective bidder/firm.
- Certificate of No Court Case/Litigation regarding delayed/ sick project with Works Department vi. and Water & Power Department GB.

TERMS & CONDITIONS:-

- The bidding documents will be issued to firm/contractors subject to production of 2% bid security in shape of CDR issued by any schedule bank in Pakistan and upon production of his/her original CNIC, renewal fee for CFY and Original PEC licence.
- The bid must be accompanied by CDR @ differential amount calculated below T/S amount if the bid/tendered amount below 20% of the T/S amount by any bidder.
- No bid shall be accepted beyond closing time as mentioned against each work.
- In case of Gazette holiday/local holiday, tender shall be opened on next working day without further intimation.
- The Bid validity will be 90 days after the date of opening of the bid.
- Clarification of bids shall only be allowed in accordance with PPRA Rule 2004 Rule 31. 6.
