- Successful bidders will have to submit 10% performance security of total bid price in shape of (CDR) from any scheduled Bank including KCBL within 07 days after bid acceptance.
- IT equipment will have to be supplied at respective District Headquarter in GB. Rates will be inclusive of all relevant fares, transportation, taxes etc.
- Single stage two envelope bidding procedure will be adopted for competitive bidding as per PPRA Rules 2004 clause 36(b).
- liabilities against the contractors Firms/Companies pending Black listed, 7 registration/renewal is not upto date, will not be eligible for participation in the bidding process.
- The bidder must have their own shop or outlet in Gilgit-Baltistan. Preference will be given to bidders having approved dealership/distributor of ISO certificate manufacture of IT equipments.
- The tender will be on item-wise. Contractors/Firms /Companies can apply having relevant professional experience fulfilling all above terms and conditions.
- In case of any dispute the decision of the Purchase Committee already constituted will be considered 10 final.
- Education Department GB reserves the right to accept or reject any or all tenders assigning reason 11 thereof.
