GENERAL INSTRUCTIONS TO BIDDERS (GITB)

Bidders should read these conditions carefully and comply strictly while sending their tenders. If the bidder finds any discrepancy, error, or omission in the tender documents he may intimate it to the **Admin Officer** in writing before the closing date for Tender.

1. Introduction

- 1.1. Name and Address of Procuring Agency (PA): National Veterinary Laboratory (NVL) Park Road, NARC Gate # 2, Chak Shahzad, Islamabad.
- 1.2. Eligible Bidders: General sales tax registered. National tax number registered. Bidders shall not be under a declaration of ineligibility for corrupt and fraudulent practices issued by the Government of Pakistan

2. Clarification of Bidding Documents:

A prospective Bidder requiring any clarification of the bidding documents may notify the PA in writing at its address. The PA will response in writing to any request for clarification of the bidding documents which it receives no later than five (05) days prior to the deadline for the submission of bids prescribed in the Bid Data Sheet. Written copies of the PA's response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective bidders that have received the bidding documents directly from the PA.

3. Preparation of Bids and Bidding Procedure

- **3.1.** The bid prepared by the Bidder, as well as all correspondences and documents relating to the bid exchange by the Bidder and the PA shall be written in English language.
- 3.2. Bid (single stage, one envelope) with the tender fee and 2% bid security must be attached Bidding Procedure: Single Stage One Envelop Bidding Procedure shall be followed.

4. General Instructions to Bidders (GITB)

- 4.1 All bids should reach the PA within due date and time as specified in the advertisement through registered post.
- 4.2. Tenders must be enclosed in a properly sealed envelope, properly marked and signed. No cutting/handmade correction in bid.
- 4.3. Rates shall be written both in words and figures. There should not be errors and / or overwritings. Corrections if any should be made clearly and initiated with dates.
- 4.4. In case of quoting alternate prices, must be on separate document.
- 4.5. The bidder shall mention validity of offer, terms of payment, guarantee/warranty period and schedule of delivery.
- 4.6. The evaluation will be based on the comparison of specification as described in the Annexure-I.

- 4.7. Supply order/ contract will be issued subject to the availability of funds as well as subject to Transfer from Funding agency.
- 4.8 The contractor shall notify forth in written form to The National Veterinary Laboratory (NVL) with any change in the constitution of the firm, etc. and such change shall not relieve any former member of the firm, etc., from any liability under the contract.
- 4.9. The National Veterinary Laboratory (NVL) reserves the right to accept any tender not necessarily the lowest, reject any tender without assigning any reasons and accept tender for all or anyone or more of the articles for which bidder has been given or distribute items of stores to more than one firm/ supplier.
- 4.10. The contractor, in respect of the contract, shall accept no new partner/ partners in the firm unless he / they agree to abide by all its terms, conditions and deposits with the National Veterinary Laboratory (NVL) a written agreement to this affect. The contractor's receipt for acknowledgement or that of any partners subsequently accepted as above shall bind all of them.
- 4.11. The contractor shall not assign or sub-let his contract or any substantial part thereof to any other agency.
- 4.12. The National Veterinary Laboratory (NVL) shall not be responsible for any loss, shortage of documents and shall have the right to dispose of such bid as it thinks fit.

5. BID Price and Validity

- 5.1. The Bidder shall indicate price of his offer, list of items with specifications, standard accessories, make and origin, the unit price and total bid prices of the goods in Pakistan Rupees (PKR).
- 5.2. All kind of taxes must be included in the quoted prices.
- 5.3. Sales Tax and Income Tax will be deducted at source from the supplier's bill as per government rules. GST will be refunded subject to the provision of Sale Tax invoice.
- 5.4 The Bid will remain valid and open for acceptance for a period of 120 days from the specified date of opening or closing of financial year on the case may be.

6. Bid Security

- 6.1. The bid must be accompanied with a bis security of 2% of the total quoted prices in favor of "DDO National Veterinary Laboratory (NVL)" (refundable).
- 6.2. The bid security shall be denominated in Pakistani rupees and shall be in the form of DD receipt issued by Pakistani bank or branch of a foreign bank, operating in Pakistan,
- 6.3. Unsuccessful bidders' bid security will be discharged or returned as promptly as possible but not later than thirty (30) days after the expiration of the period of bid validity prescribed by the PA
- 6.4. The successful Bidder's bid security will be discharged upon the Bidder's successful supply of Goods duly acceptable to the PA.
- 6.5. The bid security may be forfeited in the following cases:
 - 6.5.1. When bidder withdraws or modifies the offer, after opening of tender but before acceptance of tender

- 6.5.2. When bidder does not execute the agreement if any, prescribed within the specified time.
- 6.5.3. When the bidder submitted fake or forged documents, company authorization or misinterpretation of facts or other acts comes under the category of fraudulent practices defined in Clause-14 sub-clause14.2 of PPRA rules

7. Submission of Bids

7.1. Sealing and Marking of Bids:

The Bidder shall seal the original and each copy of the bid in separate envelopes, duly marking the envelopes as "ORIGNAL" and "COPY." The envelopes shall then be sealed in an outer envelope. The outer envelope should be clearly marked with Tender No and Tender title given on the title of this Document.

- 7.2 Bids must be received by the PA at the address specified in the Bid Data Sheet no later than the time and date specified in the Bid.
- 7.3 The PA may, at its discretion, extend this deadline for the submission of bids by amending the bidding documents, in which case all rights and obligations of the PA and bidders previously subject to the deadline will thereafter be subject to the deadline as extended
- 7.4 **Late Submission:** Any bid received by the PA after the deadline for submission of bids prescribed by the PA will be rejected and returned unopened to the Bidder.

8. Opening, Clarification and Evaluation of Bids

- 8.1 The PA will open all bids in the presence of bidders' representatives who choose to attend, at the time, on the date and at the place specified in the Bid Data Sheet. The bidders' representatives who are present shall sign a register/attendance sheet evidencing their attendance
- 8.2. The bidders' names, bid modifications or withdrawals, bid prices, discounts, and the presence or absence of requisite bid security and such other details as the PA, at its discretion, may consider appropriate, will be announced at the opening. No bid shall be rejected at bid opening, except for late bids, which shall be returned unopened to the Bidder.
- 8.3. Bids that are not opened and read out at bid opening shall not be considered further for evaluation, irrespective of the circumstances. Withdrawn bids will be returned unopened to the bidder.

- 8.4 During evaluation of the bids, the PA may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing, and no change in the prices or substance of the bid shall be sought, offered, or permitted.
- 8.5. The PA will evaluate and compare the bids which have been determined to be substantially responsive.

9. Award of Contract

- From the evaluation criteria, the PA of NVL will determine to its satisfaction the most 9.1. advantageous Bidder.
- 9.2. The determination will take into account the Bidder's compliance with the qualification criteria defined in the bidding document.
- 9.3. The PA will award the contract to the most advantageous Bidder whose bid has been determined to be substantially responsive and has been determined according to the evaluation criteria.
- 9.4 PA's Right to Increase or Decrease Quantities of the items at the time of Award, without any change in unit price or other terms and conditions.

10. Mode of Payment

- 10.1. Payment shall be made in the form of cross cheque from AGPR in accordance with the stated specifications.
- No advance payment will be made. Payments will be made subject to the clearance of account and audit cells.
