Sealed tenders are invited for supply of various equipment/machinery/toolkits/items for 07 Government Vocational & Technical Training Centers (GVTTTCs) functioning under Directorate of Technical Education and Skills Development (DTESD) Gilgit-Baltistan, Gilgit, from well reputed registered Government Contractors/Suppliers/Firms having sufficient relevant experience in supply of same equipment/machinery/toolkits/items.



TERMS AND CONDITIONS:

1. Interested bidders may submit their bids in the office of the undersigned situated at Special Education Complex Konodas Gilgit, near KIU up-to 10.05.2022 till 11.00 AM, which will be opened on the same date at 11:30 AM. In case of Islamic or Local Holiday or any other unavoidable reason the office goes "OFF", at the same day, the tender will be opened on the next day, time & venue. Tender Documents after due date and time, will not be entertained.
2. Black listed, pending liabilities against the Contractors/Firms/Companies and whose registration/renewal is not up-to date, are not eligible for participation, in the bidding process.
3. The bidder may obtain bidding documents from the office of Technical Education & Skill Development, GB near Etihad Chowk, Jamat Khana Bazar Gilgit, from Monday to Friday before closing hours up to 9th May, 2022 on payment of non-refundable amount of **Rs. 2000/-** (two thousand only). The bid will be opened on 10th May, 2022 at 11:30 AM in the Office of the Director TESD/Special Education at Special Education Complex near KIU Gilgit.
4. As PPRA Rules-2004, 2% Call Deposit Receipt (CDR) of bid amount mentioned above from any schedule Bank including Karakoram Cooperative Bank Limited (KCBL) may be attached with the Technical Bid/Tender. In case CDR is not attached with Technical Bid the Firm/Contractor/Company will be declared as non-responsive.
5. Successful bidders will have to submit 10% "**Performance Security**" of estimated cost in shape of CDR from any schedule Bank including KCBL within 07 days after bid acceptance.

6. Single stage two envelope bidding procedure will be adopted for competitive bidding as per PPRA Rules 2004 section 36(b).
7. The selected firm/contractor will have to submit an affidavit for supply of materials according to demand of the office.
8. Equipment/machinery/toolkits/items will be provided/supplied to the 07 Government Vocational & Technical Training Centers (GVTTTCs) situated at District Gilgit (Polytechnic Institute ChilmishDass), Ghizer (Gahkuch), Nagar (Sikandarabad), Skardu (Boys High School No. 1), Ghanche (Khaplu), Astore (Eidgah) & Diamer (Chilas) inclusive of all relevant fares, transportation, taxes etc.
9. On the date of Bid opening, only "Technical Proposal" will be opened whereas the envelope marked as "Financial Proposal" will be retained in the custody of the procuring employer till finalization of Technical Bids. Financial bid of qualifying Firms will be opened after finalization of Technical Bid.
10. Rates assessment will be made based on unit rates (which must be in Pakistani Currency- Rupees) quoted by the Contractor/Firm/Company and quantity, required to be purchased.
11. Quantity of required equipment/machinery/toolkits/items can be increased or decreased.
12. In case of any dispute, the decision of the Purchase Committee already constituted will be considered final.
13. The undersigned/department may reject the bids at any time/stage prior to the acceptance of a bid or proposal. The undersigned shall, upon request, communicate to any supplier or Contractor who submitted a bid or proposal, the grounds/reasons for rejection of all bids/bid or proposal, but is not required to justify those grounds.
14. The tender will be made on "lot basis". A Contractor/Firm/Company can apply only for one lot having relevant professional experience fulfilling all above terms and conditions.
15. Workshop/shops/showroom/office for minimum trades for which equipment/machinery/toolkits/items are to be procured must be situated in any district of GB.
16. Equipment will be verified online to ensure quality and originality and local channel warranty cards will also be submitted by the contractor during supply of equipment/machinery/toolkits/items.
17. The procurement committee can ask the firm/company (if feels essential) to present the sample for final approval before issuing supply order.
18. Omission/deletion/modification/changes in the name of items and unit in the bidding documents by the Contractor/Firm/Company will not be accepted.
19. Computerized entry of rates/amount by the Contractor/Firm/Company with accurate calculation will be encouraged.
