Terms and Conditions:

1. The prices should be firm and final on FCS basis without involving any foreign exchange.
2. Tender must be accompanied with a Bid Guarantee i.e. 02% amount of total offered material valid for 90 days in the form of Bank Guarantee / Call Deposit Receipt/ Demand Draft or Pay Order issued by any scheduled Bank of Pakistan (having rating A+ or above).
3. Tender documents / forms including Terms and Conditions / detailed specifications can be obtained from the office of the Chief Engineer (MM) IESCO Head Office, Islamabad against a non-refundable amount of Rs. 1000/- per tender on any working day during office hours till a day earlier from the date of opening of tender.
4. The bid should be for full tender quantity/items and bid for fraction of quantity will not be accepted.
5. Written application on company letter head along with copies of registration with Sales Tax Department (STRN, NTN registration etc.) should be produced at the time of issuance of tender documents / bid schedule.
6. All the material should conform to relevant specifications of approved samples.
7. Approved samples of furniture can be examined in the office of Chief Engineer (MM) Room No.118, IESCO Head Office, Islamabad on any working day during office hours till a day earlier from the date of opening of tender.
8. No tender will be issued on the date of opening of tenders.
9. The bids are valid for sixty (60) days.
10. In case of holiday announced by the Govt. of Pakistan, Strike in IESCO or any other reasons whatsoever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at same time and place/venue.
11. The blacklisted firm by any Govt. Agency is not eligible for participation in the tender. The firm should submit an affidavit stating that their firm has not been blacklisted by any Govt. / Semi Govt. / Autonomous body and no legal action is underway against their firm.
