National Highway Authority (NHA) invites e-bids from eligible construction firms registered with income tax department having valid PEC registration in the respective category for individual bidder or as stated in Bid document in case of JV with specialization in CE-10 for works for "Construction of Boundary Wall to secure Highway Research & Training Centre (HRTC) Land through Road Maintenance Account (RMA)".

Constructors, having valid PEC registration as mentioned above valid for the year up to 30<sup>th</sup> June 2022 are required to create their "Online User Account" for participation in the bidding. User Guide, illustrating the steps to create "On-line User Account", is available at <a href="https://www.ebidding.nha.gov.pk">www.ebidding.nha.gov.pk</a>. Access to 'NHA e-bidding system' for bidding, will be granted upon submission of pre-requisite documents as per guide line. Bid submitted, by using NHA e-bidding system, will only be considered, whereas other bids will be rejected.
- 3. Complete set of bidding documents for the above-mentioned Works, containing detailed terms & conditions, method of procurement (Single Stage Two Envelope procedure), submission of e-Bids, Bid Security, bid validity, opening of e-Bid, Evaluation Criteria, etc. will be available on NHA website by 18<sup>th</sup> April 2022 for downloading free of cost. Moreover, Pre-Bid Meeting will be held on 26<sup>th</sup> April 2022 at 1100 hours in the NHA Auditorium (HQ) Islamabad. Bidders are also advised to follow the NHA website/e-bidding portal for updates of bidding schedule and addendum(s), if any.
- 4. The e-bid must be prepared and submitted through NHA e-Bidding system in accordance with the instructions contained in the bidding documents. Hard copy of e-Bid prepared through NHA e-Bidding system, must reach at the address mentioned below on or before 10<sup>th</sup> May 2022 until 1100 hours. Technical e-Bids (submitted through NHA e-Bidding system) and envelope containing hard copy of Technical e-Bid, will be opened on the same day at 1130 hours.
