- The tender documents will be available from the date of publication of this tender notice on PPRA & FBR Websites during office hours on payment of Rs:2000/- per tender (Non-refundable).
- The bids should reach this office within fifteen (15) 03:30PM days of the publication of this Notice on PPRA & FBR Websites after which bids will not be entertained.

All the bids should reach this Office within the prescribed time limit and same will be opened by Tender Committee, Regional Tax Office, Sukkur in the presence of bidders who are required to attend at 4:30pm on the closing date, in the Conference Room of Regional Tax Office, Queens's Road Sukkur.
- Each bid is to be accompanied with a sample of the item in the form which the bidder will supply.
 (all sample will remain in custody upto award of supply/contract to the successful bidder by tender committee).
- Any type of correcting fluid or over-writing will not be acceptable on the Tender Form and only typed quotations will be considered.
- 8. All Government Taxes will be deducted as per laws/rules.
- The bidder should enclose a copy of each of NTN certificate, Sales Tax Registration No. & CNIC
 of the proprietor & profile of company with Engineering Council Registration Certificate for
 Building works bidders.
- Incomplete tender form will not be accepted in any case.
