Terms and Conditions:-

- 1. The participants will submit call Deposit/CDR in favour of Dean/Principal, Federal Medical College, Islamabad Rs. 20,000/-(Rupees twenty thousand only) (re-fundable) for participation in auction.
- 2. The successful bidders will deposit 25% of the total auctioned on the same day and remaining amount will be deposited within 03 days positively after the issuance of Award Letter.
- 3. The successful bidder will take away auctioned items within 20-days positively after the issuance of Award Letter, in case of failure, 10% of total value shall be charged as rent/penalty.
- 4. If Successful bidder fails to take away the auctioned items within 30-days, 100% of deposit at call & deposited amount 25% shall be forfeited in favour of Government of Pakistan.
- 5. All participants are requested to bring their Original CNIC issued by NADRA/Passport/B-form for participation in Open Auction process, without original documents, nobody will be entertained.
- 6. Inspection/Visit may be made by interested parties from 09:00 AM to 01:00 PM at FMC & contact focal person i.e. Store Keeper, FMC. However, items of S.no 4 may be inspected of FMC Girls Hostel NIH Colony Chak Shahzad Islamabad.
- 7. The FMC employees are not allowed to participate in auction process.
- 8. The successful bidder will pay all prevailing Government Taxes/Duties as admissible under the Rule in addition to the successful bidding amount.
