**INVITATION TO BID.**

1. The Public Health Engineering (PHE) Division Gilgit invites sealed bids for following works under "**Single Stage Two Envelop**" (SSTE) procedure from contractors / firms registered with Pakistan Engineering council having valid registration certificate (2021-22) in relevant category (C-4 & above) and code (CE-09) duly renewed with GB Public Works Department for the year 2021-22.
2. Interested firms /contractors can purchase the bidding documents from the office of Executive Engineer PHE Division upon submission of application with nonrefundable cash for an amount of Rs. 5,000/- (Rupees five thousand only) for each work being cost of bidding documents during working hours.
3. The Contractors/ Firms should provide certificate from concerned Divisions that they do not have sick schemes in hand and they have not been black listed.
4. The bid shall comprise a single stage two Envelop (containing two separate envelopes). Each envelope shall contain separately the technical and financial proposal marked "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**" in bold legible letters to avoid confusion [PPRA- Rule 36(b)]. Initially, only the envelope marked "**TECHNICAL PROPOSAL**" shall be opened and the envelope marked as "**FINANCIAL PROPOSAL**" shall be retained in the custody of the procuring agency without being opened. Second envelope containing financial Bids will be opened later; the date of which will be communicated to the successful bidders of technical Bids. Financial Bids of non-qualified / non responsive technical bidders will be returned unopened.
5. The earnest money/ bid security in shape of pay order or bank draft from any scheduled bank in favor of Executive Engineer PHE Division Gilgit shall be attached with the "**TECHNICAL PROPOSAL**". In case of failure, bid documents will not be considered.
6. Technical Bid of Firms/ joint ventures will be evaluated on the criteria duly approved by Works Department GB
7. Conditional bids and bids received after due date and time will not be accepted.
8. The Procuring Agency reserves the right to reject all bids at any time prior to acceptance of a bid or proposal [PPRA-Rule-33 of 2004].
