QUOTATION

Sealed quotations on specified form with detailed specification to be obtained from the Office of Cantonment Board Bahawalpur against prescribed fee are invited from well reputed / bidders / manufactures / authorized dealers who are registered with FBR for Income Tax, Sales Tax, under PPRA Rules 2004 on single stage two envelope procedure for Supply / Fixing of Zip line & Rock Climbing wall at Gulzar e Sadiq Park, Bahawalpur Cantt.

Terms & Conditions.

- 1. The Quotation should be free from cutting / overwriting etc.
- 2. The bidding document can be obtained from this office on any working day during office hours on payment or Rs. 3000/- (non-refundable) as mentioned above till 12th May, 2022 at 1200 noon sharp and same will be opened on 12th May, 2022 at 1230 hours. Financial bid of the technically qualified bidders will be opened on 13th May, 2022 at 1230 hours in presence of bidders / authorized agents.
- 3. The bidder shall require to submit bid security equivalent to 5% of the project cost alongwith quotation form during the bidding time.
- 4. The eligible bidder are required to submit their bids for work in separate sealed envelopes i.e. one envelope containing "Technical Proposal" of the bidder clearly marked as "Technical Bid" accompanied with respective bidding document fee, while the second envelope containing financial proposal / bids price, clearly marked as financial proposal. Both Technical and financial proposal / bids will be placed in single sealed envelope dully addressed and send to office of the Cantonment Board Bahawalpur, Ahmadpur Road, Bahawalpur Cantt within due date & time of closing of tender box.
- 5. Technical proposal must be numbered & a table of contents inserted at beginning of the proposal showing the table of contents of the proposal according to the numbered pages. All pages of bids shall be signed & stamped by the bidder and seal be affixed alongwith the signature / initials / stamps
- 6. The "Technical Proposal/ Bids" of the bidder will be evaluated in accordance with laid down evaluation criteria based on following documents to be provided in the bidding documents meant for submission of Technical Proposal.
 - i. Bidder / company address, name / profile and previous relevant experience supported by documentary evidence.
 - ii. Financial status, Bank Balance & certificate from the scheduled bank for the last 01 year.
 - iii. The Income tax certificate from the concerned Agency.
 - iv. Import / Export, technical support and availability of complete setup in Bahawalpur.
 - v. An affidavit that firm is neither blacklisted nor in dispute / litigation / arbitration with any govt / semi govt department on the left over / incomplete projects.
 - vi. An affidavit is required to be provided with the technical bid regarding attachment of the bid security in the shape of bank guarantee or call deposit with the financial bid.
 - vii. If any document submitted along with bid documents found false / bogus, the registration of the firm / contractor shall be stand cancelled / blacklisted in the light of

enabling provision of PPRA Rules 2014. Conditional / incomplete bids shall not be acceptable.

- 7. The financial bids / proposal of only technically responsive qualified bidders will be opened after evaluation of Technical bids in the presence of bidder / their representatives in the office of Cantonment Board Bahawalpur on the date & time to be notified later on whereas the financial bids of technically non responsive bidders shall be returned unopened to the respective contractor.
- 8. All the government taxes will be deducted as per prevailing government policy.
- 9. Any bidder received in the contravention of enabling provisions of the PPRA Rules, 2004 will be declared non responsive by the procuring entity. Cantonment Board Bahawalpur being procuring entity reserves the right to accept or reject any tender / bid on technical administrative ground under rule 33 (1) Rules, 2004.
- 10. Successful bidder shall be bound to execute an agreement with the procuring entity and all terms & conditions including tender notice shall be binding on the bidder.
- 11. The Bidder shall provide after service after 01 years period against the defect liability.
- 12. As per PPRA Rule 33, the procuring agency may reject all bids proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any bidder / contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.
- 13. Further details terms and conditions can be obtained from the office of the Cantonment Board Bahawalpur Cantt on any working day and are available on website of the Bahawalpur Cantonment Board.
