- 2. The Firms must have valid registration with PEC in the relevant field and code and valid income Tax/ services Tax registration with FBR "along with proof of office Establishment/ Branch in Pakistan.
- Interested firms may purchase the RFP documents from office of the undersigned and M/o KA & GB, Room No. 131 'R' Block, Pak Secretariat, Islamabad) during office hours (0900 Hrs to 1700 Hrs) upon non-refundable Cash payment of Rs.8000/-up to 25 May, 2022 bidders will be "Post Qualified" on the basis of information provided with the proposals, Firms who fail to qualify in this respect shall not be considered further.
- 4. The bidder should visit the project site to get acquainted with the existing conditions and also to get familiar with the quantum of work and nature of assignment. A joint visit to the project site can be arranged on request.
- A pre-bid meeting will be held on, 17<sup>th</sup> May 2022 at 10:00 Hrs in the Conference Room of M/o KA & GB, 1<sup>st</sup> Floor "R" Block, Pak Secretariat, Islamabad. Single stage –Two envelope procedure will be adopted. One envelope containing technical information of proposals should be clearly marked as "Technical proposal" and the second envelope containing the proposal price should be clearly marked as "Financial Proposal" (one original two copies).

- Partial and incomplete bids will not be considered. "Technical proposal" and "Financial proposal" (both envelopes) must be delivered to M/o KA & GB, Room No. 131, 1st Floor "R" Block Pak Secretariat, Islamabad on or before ,25th May, 2022 at 1100 Hrs. The envelopes containing technical proposal shall be opened on the same date at 1130 Hrs in the M/o KA & GB, Conference Room, 1st Floor "R" Block Pak Secretariat, Islamabad in the presence of those bidders who choose to be present. Proposals received after the prescribed time and date shall be rejected.
- 7. The envelope of "Financial proposal" of the firms who fail to post-qualify shall be retuned unopened. The decision of Bid opening & evaluation committee shall be final and binding on the firms and it will not entertain any claim whatsoever on the basis of cost incurred by the firms for preparation of bids.
- 8. The envelope of "Financial proposal" of only "Technically Responsive & Qualified Firms" will be opened in the presence of their respective representatives at the date and time to be determined and communicated later.
- 9. All the applicable Federal/ Provincial taxes must be considered while preparing the Financial Proposal and are required to be built in the quoted rates and not be mentions separately. Provision of forged, fake, false, unsubstantiated, incomplete information may lead to deduction of marks and disqualification and/ or blacklisting.
