- Tender shall be issued only to the Owner of the Firm. In case of partnership, only the persons mentioned in the partnership deed/form-H will be allowed, attested copy of partnership deed/ Form-H should be produced to receive / submit the tender document.
- 2. No tenders will be sold by post or on the date of opening of tender.
- 3. Earnest money amounting as specified mentioned below in the shape of Call Deposit (showing the name of firm) in favour of the Executive Engineer, Central Civil Division-VIII, Pak PWD, Islamabad issued by any scheduled Bank functioning at Rawalpindi / Islamabad from the account of applicant firms must be submitted at the time of purchase of biding documents.
- 4. Firm must have completed at least 01 No. of similar nature of building project amounting to rupees 70% of the cost of project during the last 03-Years. Work order and completion certificate of the project attested by the concerned Project Director / Executive Engineer should be submitted along with application at the time of purchase of tender. Work order below rupees 70% of the cost of project will not be considered.
- 5. The firm must have completed at least 01 No. project timely within stipulated time period mentioned in work order certificate, documentary proof will also be provided with application attested by concerned Project Director / Executive Engineer.
- 6. Those project who's letter of starts and completion certificate are not provided, or those which are not attested by concerned Project Director / Executive Engineer, will not be considered.
- 7. The Firm must be+(e-filer) and provide Active Tax Payer Certificate.
- 8. Each page of the bid must be signed with stamp of company.
- 9. Those contractors who have quoted abnormally below rates as compared with Engineers estimate they will furnish an additional CDR equal to the difference of cost along with rate analysis to protect employers interest in accordance with clause 28.4 of PEC bidding.
- 10. List of Machinery Equipment, Technical Staff working with firm must be provided on Judicial stamp paper Rs.100/- dully attested by Notary public.
- 11. The affidavit on stamp paper of Rs.100/- certifying that the firm has never been black listed by the Government / Autonomous body be submitted along with application.

The Contractor/Firm have to provide documentary evidence of Annual construction Turnover and working capital of the last financial year (2020-21) which should not be less than rupees 70% of the cost of project which must be attested by concerned auditor / Audit firm be submitted with the application.
- 13. An affidavit regarding authenticity of all information provided for purchase of tenders should be enclosed with the documents if any information is found incorrect fake or forged the tender of the firm will be cancelled and legal action will be taken against the firm.

Financial soundness of the Firm in shape of bank statement duly certified by the concerned Bank Certifying available bank balance at least equal to 50% of cost of project or greater account balance during the month of submission of Bid which must be enclosed with application otherwise the proposal will be rejected.
