1 Army Desert Warfare School Chhor Cantonment intends to purchase of Icom communication equipment with allied accessories for exercise / training events:-

a. **Rates**

- (1) Quoted rates must be valid upto 17 May 2022
- (2) Quoted rates must be inclusive of all the government taxes i.e
 GST Income Tax and Other
- (3) Rate will be quoted for brand new items

b. **Quotations**

- (1) Quotation must be provided on letter head of the firm and each page must bear firm's stamp and representative's signature. Soft copy of the same is also required.
- (2) The firm has to provide original import documents for imported store if asked by the Institution
- (3) No columns should be left blank in quotation, however, "NQ" should be written in column for **Items Not Being Quoted**.
- (4) Delivery period of the quoted stores must be mentioned in your quotation.

c. **Restriction**

- (1) **Cutting or Over writing** in the quotation makes it liable to rejection, same may be avoided
- (2) The purchaser will reject all bids or proposals at any time prior to the acceptance of a bid or proposal.

d. **Supply Requirements**

- (1) The store (s) / item(s) should be exactly in accordance with the specification

- (2) Samples of the quoted items may be demanded from the firms to assess the quality, technical feasibility and functionality of the item

e. Tender Opening

- (1) Quotation must be dropped in the tender box before 1000 hours on 18 May 2022
- (2) Technical tender will be opened on 18 May 2022 at 1200 hours.
- (3) Commercial tender will be opened on 18 May 2022 at 1300 hours
- (4) No quotation will be accepted after due date and time

f. Importance Note

- (1) Delivery period will be 15 days after the award of contract, failing which contract may be cancelled
- (2) Only GHQ security wise cleared firms, registered with this installation any other Defense organization can participate in this tender inquiry
- (3) The firm has to deposit Rs 200/- in cash per tender at the time of submitting the quotations. Otherwise, their quotation will not be included in bidding process
- (4) This tender is available on PPRA website.
- (5) Rate of each item will be considered separately.
- (6) Technical quotes of the tender will be opened prior to the opening of commercial quotes for the firms/ contractors not fulfilling the technical requirement will not be included.

g. Warning

- (1) Do carefully study the specifications of store (s) / item (s) of this tender inquiry before quoting otherwise for wrong quotation Army Desert Warfare School will not be responsible
- (2) Do read all clauses carefully before preparing the quotations.
