1. With reference to the IFB Notice published in press and uploaded on NHA & PPRA websites dated 6th December 2020, all the prospective Bidders are informed that the previous procurement process has been annulled in accordance with PPRA Rule-33 and re-tender as under.
2. National Highway Authority (NHA) invites e-bids from eligible constructors, registered with income tax department and who are on Active Taxpayers List of the Federal Board of Revenue, having valid PEC registration in category **CB or above** with specialization in **CE-01 & CE-02** for year 2021-22 for **“Construction of Additional Carriageway Petaro – Sehwan (N-55) Section-I (64 KM): Package – IC – Construction of Additional Carriageway Petaro – Sehwan (N-55) (KM 40+000 ~ KM 64+000)”**.
3. The bidding shall be done through NHA e-Bidding System. Constructors, having valid PEC registration are required to create their “On-line User Account” for participation in the bidding. User Guide, illustrating the steps to create “On-line User Account”, is available at www.ebidding.nha.gov.pk. Access to ‘NHA e-bidding system’ for bidding, will be granted upon submission of pre-requisite documents as per guide line. Bid submitted, by using NHA e-bidding system, will only be considered, whereas other bids will be rejected. User Guide and video tutorial for Preparation & Submission of e-Bids are also available on homepage of NHA e-Bidding website.
4. Pre-Bid Meeting will be held on **23rd April, 2022 at 1100 hours** in the NHA Auditorium (HQ) Islamabad.
5. Complete set of bidding documents for the above mentioned Works, containing detailed terms & conditions, method of procurement (Single Stage - Two Envelope procedure), submission of e-Bids, Bid Security, bid validity, opening of e-Bid, Evaluation Criteria, etc. will be available on NHA website on 15th April, 2022 for downloading free of cost.
