TERMS & CONDITIONS:-

1. The bidding documents will be issued to firm/contractors subject to production of 2% bid security in shape of CDR issued by any schedule bank in Pakistan and upon production of his/her original CNIC, renewal fee for CFY and Original PEC licence.
2. The bid must be accompanied by CDR @ differential amount calculated below T/S amount if the bid/tendered amount below 20% of the T/S amount by any bidder.
3. No bid shall be accepted beyond closing time as mentioned against each work.
