02. Provision of Certain Facilities at PAF Base (W) Rs. 30.000 Million

03. The contractors are required to submit their applications for issuance of tender documents alongwith their complete credentials as shown at (Serial 9). The applications shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tender must be received in the office of Accepting Officer by 1130 Hrs on **26 May' 2022** and will be opened at 1200 Hrs on the same date.
