1. General:

Superstructure along with required equipment compatible for mounting onto Hyundai Porter H-100 Truck Chassis be provided by the supplier.

2. Crew Compartment:

Compartment for 2 persons with doors on either side of the vehicle.

3. Locker Compartment:

Locker compartment is provided on sides of body for storage of Fire Fighting Accessories/Rescue Equipment. The locker is made out of 14 SWG sheet. Aluminum shutters for easy access are provided on either side of the vehicle.

4. Power Take-Off (Inline PTO):

The PTO is operated by a switch for engagement and disengagement of PTO is provided in the Driver's Cabin.
