- i. The Procurement method as per Public Procurement Rule 36(a) will be observed for the processing of this tender and the bid shall be evaluated on the basis of most advantageous quoted prices of the above mentioned items.
- ii. Bidders are required to submit a Bid Bond in shape of Call Deposit, Demand Draft, Pay Order or Bankers Cheque for a value of Rs.10,000/- (Rupees ten thousand only) in favor of Joint Director, Regional Directorate of National Savings, Abbottabad along with the bidding documents as bid security without which the bid will be rejected.
- iii. Any Bid not accompanied by the bid security shall be rejected as non-responsive. The bid security shall be refundable not later than 14 days from the date of signing of contract agreement by the successful bidder.
- iv. The bid security of unsuccessful bidder will be returned without any interest, as promptly as possible: however the bid security of the 2nd lowest bidder will be will be return on acceptance of offer letter by the successful bidder(s) or bid validity as the case may be.
