


MEPCO GALLOP TENDER NOTICE

01. Sealed tenders are hereby invited from contractors approved by Pakistan Engineering Council Class A, B, C & D renewed for the year 2022 having field specialization (EE 04/EE 05 or EE 06) for the below mentioned works at sr. No 11. The Contractors are bound to produce the documents in original & all copies must be duly attested.
02. The Tenders will be received in the office of Executive Engineer (OP) MEPCO Division DG Khan 06.06.2022 at 02:00 PM and each will be opened separately on same date after 30 Minutes of closing time of bids as per PPRA Rules, in the presence of contractors or their authorized representatives, who may care to attend. The contractor shall deposit 03% earnest money of the tender amount in the shape of call deposit issued by Scheduled Banks in Pakistan or from a foreign Banks duly counter guarantee by a scheduled Bank in Pakistan before issuance of each tender book.
03. Tender will not be issued to those contractors whose performance of work remained unsatisfactory during previous year or failed to complete the previous work.
04. No work will be issued to the firm whose registration expired, unless it provides the fresh / valid registration certificate of PEC.
05. The wires and clustering frames will be provided by MEPCO (OP) Division DG Khan for clustering of electricity meters.
06. The rate quoted by less than 20% from analyzed calculated rates / previous approved tenders rates, the contractor have to submit 05% of total bid as performance security in the shape of CDR within 15 days before approval of rates, in case of non-submission of 05% security within 15 days, the competent Authority has right reserved for cancellation of tender and 03% earnest money also would be forfeited.
07. The 05% security will be returned to contractor on successfully completion of works, otherwise earnest money i.e 05% will be forfeited.
08. Tender can be obtained from office of the Executive Engineer (OP) MEPCO Division DG Khan on payment of Rs 2000/- (Non-refundable) from 07 days before opening of tenders from 09:00 AM to 05:00 PM. No tender will be sold on the date of opening; conditional tender will not be accepted. All rights reserved for cancellation of all, or part there of the bid by the Competent Authority.
09. All the proceeding of the tender will be observed according to PPRA Rules.
10. Time Period of rates shall remain one year (i.e from the date of agreement) which can be curtailed / extended as per MEPCO requirement or till completion of bid amount, whichever is better in the interest of MEPCO.
