A) SUBMISSIONOF TENDER

1. You are required to send your tenders addressed to GM Contact Management, Supply Chain Management Department, PIA Head Office, JIAP Karachi latest by **30-05-2022 till 1030 Hrs.** The tenders may be dropped in the tender box marked as **"Tender Box Commercial Purchases"** placed at the entrance of the PIA Supply Chain Management latest by**10:30 hours** on the specified date. You may also send your tenders through registered A/D mail addressed to GM Contact Management, which must reach before the closing date and time mentioned above. Tenders will be opened at**11:00** hours on the same day in the presence of tenderers.

2. Tenders received after stipulated date & time shall not be considered. The Corporation will not be responsible for postal delays. The decision of GM Contract Management in this respect shall be final and binding.

3. Bidders are required to submit a Pay Order of Rs.10,000/- (Not Refundable) as tender fee in the name of M/S PAKISTAN INTERNATIONAL AIRLINES along with Technical Proposal.

B) <u>EARNEST MONEY/BID SECURITY</u> (For Local Bidders Only)

The Tender should be accompanied by a Pay Order equivalent to 2% of total contract value in the name of M/S PAKISTAN INTERNATIONAL AIRLINES as interest free Earnest Money (Refundable). - After Technical Evaluation of the received Technical Proposals, Financial Proposals will be opened publicly at the date, time & venue to be announced and will be communicated to the bidders in advance.
- PIA will open the "Financial Proposals" publicly of the parties whose Technical Proposals have been found acceptable.
- Financial Proposals of the technically not-acceptable bids shall be remained unopened till the completion of tender process.

- c) Undertaking on Rs. 100/= above non-judicial Stamp Paper duly signed and stamped by a Public Notary Oath Commissioner (Local Bidders Only).
- d) The outer cover should bear address of the General Manager Contract Management, PIA SCM Building, Karachi Airport and reference number of the tender with opening date of tender.
- e) All information about the services /material proposed to be supplied must be given as required in the schedule to tender.

G) PRICES

Wireless Internet Devices

Wireless Internet Services for PIACL Officials

Introduction

Pakistan International Airlines Corporation Limited (hereafter referred to as PIACL) is looking for Service Provider(s) to provide Wireless Internet services to its officials. These services shall be provided through Battery operated portable Wireless Internet Router Devices (4 G/ LTE MiFi) so that officials can use them in offices, on the move, and at homes. The coverage area is across Pakistan.

PIACL invites vendors to submit proposals according to the terms and conditions listed throughout this document. This Request for Proposal (RFP) will serve to provide vendors with the requirements, evaluation criteria, and other information required for the Battery operated portable Wireless Internet Router Devices (4 G /LTE MiFi) across Pakistan.

Scope of work

- 1. Service Provider(s) to provide uninterrupted services to PIACL officials across Pakistan. Services should be 4G or LTE-based and must have downward compatibility to 3G.
- 2. Service Provider(s) shall provide rates for 100 GB data Buckets. Only PIA ICT department shall provide list of authorized persons and all correspondence related to services shall be done by PIA ICT department. However, if an authorized person consumes more than 100 GB data buckets then the service provider shall directly bill to the authorized subscriber for additional data after. PIACL will not pay for additional data.
- 3. For bid value calculation purpose, 100 Devices can be considered; however, this number is neither a guarantee nor a capping and shall be considered just for bid value calculation. Billing will be submitted to PIACL, I&CT Department and paid on an actual number of devices as per data buckets rates.
- 4. These services will be acquired for three (3) years.
- 5. PIACL will sign a contract with the successful bidder. The contract's terms and conditions will be finalized after vendor selection. However, this contract by no means shall provide exclusivity rights to the selected Service Provider for these services. PIACL may acquire the same services with other service providers (s) as per need and service quality across Pakistan.
- 6. Faulty/out-of-order devices shall be considered for free replacement. Replacement time must be within 24 hours after launching a replacement request.
- 7. Agreement will be finalized and signed with successful bidder later with mutual consent.



Duration and Termination

- 1. This contract shall be for a term of Three (03) years.
- 2. At the end of the contractual term, the services may be renewed for successive periods of further two terms of 01 year each on same rates terms and conditions on mutual consent basis subject to satisfactory performance.
- 3. Either Party may without prejudice to its other rights under the law or in equity terminate the Agreement by notice in writing of sixty (60) days, at any time during the term of this Agreement.
- 4. Agreement will be finalized with successful bidder later on.
- 5. Agreement shall be governed and interpreted in accordance with the Laws of Pakistan.

General Terms & Conditions

- 1. Incomplete and conditional responses will not be entertained.
- 2. PIAC reserves the right to accept/reject wholly or partially any response or cancel the tender process altogether at any stage without assigning any reason.
- 3. Responses are liable to be rejected if; they are not conforming to the terms, conditions, and specifications stipulated in this document.
- 4. Responses submitted via email or fax will not be entertained
- 5. Vendor shall submit a financial bid on the basis of 100 devices. Bid Security and Performance Guarantee will be calculated as the Rate multiplied by 100 devices for a period of 3 years.
- 6. During the three years' contract period, the number of devices may vary according to PIACL need. Payment shall be made at an actual number of active devices in use of PIA
- 7. Bid Security/Earnest Money shall be furnished by the bidder 2% of total bid value along with financial bid.
- 8. Performance Guarantee/Security Deposit equal to 5% of the total contract value shall be provided by the selected bidder(s) up to the satisfaction of PIACL before the execution of the Agreement.

Acceptance, Award, and Rejection

1. PIACL reserves the right to terminate the process without awarding the contract.



- 2. PIACL reserves the right to accept or reject any part, or all, of each proposal submission and/or not to make an award if none of the proposals received meet the requirements.
- 3. PIACL will not be responsible in law or in equity to any proponent for any claim for losses or damages, or any other relief, arising out of the RFP process including the selection or rejection of any particular section of this proposal.
- 4. PIACL interpretation of the contents of the official proposal documents shall prevail.
- 5. PIACL reserves the right to select as many vendors as it deems necessary.

Terms of Payment

- 1. Payment shall be released after delivery of services in accordance with the requirements of this agreement and up to the satisfaction of the Company within 45 days after the submission of invoice and relevant documents. Payments will be made in Pak Rupees on monthly basis. Payments will be made as per the actual number of devices utilized by PIACL.
- 2. All payments shall be subject to any and all taxes, duties and levies applicable under the laws of Pakistan for the whole period starting from the issuance of Acceptance Letter, till termination of the signed agreement in this regard. In case of any compromised services or any payables, Government taxes which the service provider fails to deposit, such payments may be subjected to deductions of any amount payable by the Service Provider to the Company, in case of services compromised or any government taxes which the service provider fails to deposit including but not limited to damages, etc.
- 3. No Advance payments shall be made.
