- 1) The Chief Commissioner Inland Revenue, Corporate Tax Office, Lahore reserves the right to reject all bids at any time prior to award of Contract (s) without thereby incurring any liability to the affected bidder or bidders or any obligation inform the affected bidder or of the grounds for Chief Commissioner action.
- 2) Income / Withholding Taxes will be deducted in accordance with the law. The Sales Tax shall also be deducted in accordance with the law.

#### 3) DELIVERY SCHEDULE

The provision of supply of **Antivirus Software** of Requirement Annexure "B" is required within a week (in Lahore at the premises) after award of the contract (s) to be issued against this tender inquiry. So, the lowest bidder may be in a position to complete delivery with the given time frame.

#### 4) PENALTY:

For failure to comply with delivery schedule of Supply and installation Order (s) to be issued against this tender document, penalty will be imposed on defaulting Supplier as under:

- 5.1 1% of the cost of entire supply order of such supply order(s) as remains unsupplied / un-completed for every day up to maximum of 5% for 10 days exceeding the supply period.
- 5.2 If the supply of **Antivirus Software** are not supplied or not installed even after payment of penalty for 10 consecutive days the Chief Commissioner Inland Revenue, Corporate Tax Office, Lahore reserves the right to cancel the supply and installation order and to purchase required items elsewhere at risk and cost of the defaulting Supplier.
- 5) Quoted rates must be inclusive of all taxes (Sales Tax etc.) & in Pak Rupees.

Rates must be quoted including all charges like travelling & transportation of the supply of Antivirus Software.

- 6) Bidding Form Annexure "A" must also be duly filled in, stamped and signed by authorized representative of the bidder.
- 7) Quoted rates shall be valid for at least one (1) year from the opening date of the bid. However, any subsequent change in taxes and duties as notified by Federal Board of Revenue will be given due consideration.
