Ministry of Information and Broadcasting intends to establish Digital Media Production Studios in 22 major Press Clubs throughout the Country in the first phase to facilitate and empower journalists to perform their professional duties.

Sealed bids are invited from Active National and Sales Tax Registered (where applicable) firms/General Order Suppliers for providing services for supply & installation of following electronic equipment, IT equipment and furniture & fixture for establishing 'Digital Media Production Studios' initially in 22 major Press Clubs.

3. Terms and conditions for submission of bids will be as under:-

- i. The bidding process will be single stage – two envelopes as per PPRA Rules 38-2(a).
- ii. Interested bidders shall submit two separate envelopes clearly marked "Technical Bid" and "Financial Bid".
- iii. The bidding firm will submit earnest money of Rs.200,000/- (rupees two hundred thousand only) in the form of Pay Order/Bank Draft only in favour of DDO, M/o Information & Broadcasting as bid security along with bids. Bids without earnest money will not be accepted.

- iv. The bidder should have minimum 5 years relevant working experience and should be financially sound. To prove this the bidder should attach copies of their Company Profile, certificate/documents indicating relevant experience, Managerial Capacity, Financial Position/last three year's bank financial statement, Active STN (where applicable) with the bids.
- v. The Ministry may increase or decrease the quantity of tender items depending upon the availability of budget.
- vi. The Ministry reserves the right to accept or reject any bid or bids and may cancel part or whole tender as per provisions of PPRA rules.
- vii. Bids (Technical as well as Financial), complete in all respect, should reach undersigned by hand or by courier or by post within fifteen (15) days from publication of the tender notice but not later than 02.06.2022 before close of office hours at 3:00 p.m. Bids received after deadline shall not be entertained.
- viii. Bidders should provide an affidavit that they are not blacklisted by any government department or agency for participating in tenders in public sector
- ix. Technical bids will be opened and evaluated by the Evaluation Committee as per evaluation criteria given in the bidding document on very next day of the closing date of tender at 1:00 p.m in presence of bidders or their authorized representatives in the committee room of M/o Information and Broadcasting, 4th Floor, Cabinet Block, Islamabad. Financial bids of technically qualified firms will be opened on next day.
