- 1. Bids shall be accepted only on Tender Document Form to be collected from Purchase Section on deposit of Rs. 1000/- cash (bank challan available from PITAC Cash Section) Non- Refundable at NBP PCSIR Branch, Lahore during working hours.
- 2. The earnest money of Rs. 50,000/- in the shape of deposit at call or a bank guarantee issued by a scheduled bank in the name of Director General PITAC, Lahore must accompany with the Bid, without earnest money, bid will be rejected.
- 3. Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) <u>Single stage single envelope</u> procedure.
- 4. The Bids in sealed envelope should reach to the undersigned, on or before above mentioned date at 11:00 AM. Bids will be opened on the same day at 11:30 AM.
- 5. The bids of any bidder shall be declared non-responsive, if he is found involved in litigation with any government or semi-government department.
- 6. The bidders should be on active taxpayers list of FBR, valid copies of Company Registration, Income & Sales Tax Registration Certificates will be attached.
- 7. Bids should be inclusive of all government Taxes.
- 8. Government Taxes will be deducted at the time of payment as per Government prescribed rates.
- 9. PITAC reserves the right to reject all bids as per rule 33 PPRA 2004.
- 10. Quoted rates/price shall remain valid for a period of 01 year.
- 11. The firm has to submit an affidavit on Stamp Paper, being not blacklisted from any Govt.
