CONTRACTS FOR OPERATION, MANAGEMENT & MAINTENANCE OF SERVICE AREAS AT FOLLOWING SITES ON SUKKUR – MULTAN MOTORWAY (M-5) ON ADVANCE NET GUARANTEED REVENUE BASIS:

- i. Rohri service area north & south bounds KM-397+847
- ii. Azampur service area north & south bounds KM-528+035
- iii. **Zahirpir** service area north & south bounds KM-609+910
- iv. Uch Sharif service area north & south bounds KM-697+700

1. Sukkur - Multan Motorway M-5 is a six (06) lane 392 KMs long, access controlled Motorway, which is an integral link of CPEC (China – Pakistan Economic Corridor).

2. NHA envisages to engage OM&M (Operation, Management & Maintenance) Operator having valid PEC License in operators' category O-4 or above for Operation & Management of above mentioned Service Areas on advance net guaranteed revenue basis.

3. The time period of this contract will be <u>ten (10)</u> years.

4. On completion of contract period, the operator shall hand over all the amenities/installations to NHA in a properly maintained and operational condition without any claim to cost of repair and maintenance.

The bidding document comprising detailed terms & conditions, scope and bidding form, can be obtained from the office of Director (FR/HB) NHA-HQ, Islamabad during office hours after **Tuesday, 24th May 2022** by depositing Rs. 2,000/- (non-refundable) in form of pay order in favour of NHA Road Maintenance Account, Islamabad. The bid(s) for each service area complete in all respects are to be submitted separately on or before **Thursday**, **09**th **June**, **2022** at or before **1100 Hrs** on in NHA Auditorium, Islamabad. The received bids will be opened on the same day at **1130 Hrs**.
