- i. Applications for receiving bidding documents should be on original letter pad of the contractor with signature.
- ii. Contractor/Firms have to provide original PEC license with validity up to 30th June, 2022.
- iii. Renewal receipt GB-PWD for CFY (2021-22).
- iv. No Sick Project in hand (will conformed from Works Secretariat)/affidavit by the contractor.
- v. CNIC of the Prospective bidder/firm.
- vi. Certificate of No Court Case/Litigation regarding delayed/ sick project with Works Department and Water & Power Department GB.

TERMS & CONDITIONS:-

- 1. The bidding documents will be issued to firm/contractors subject to production of 3% bid security in shape of CDR/SDR issued by any schedule bank in Pakistan and upon production of his/her original CNIC, renewal fee for CFY 2021-22 and Original PEC license.
- 2. Rates quoted below 10% upto 20% of T/S amount, the advantageous bidder shall have to deposit additional performance guarantee 75% of difference amount within (05 days) five working days, in shape of CDR from any Schedule Bank of Pakistan.
- No bid shall be accepted beyond closing time as mentioned against each work.
- 4. In case of local holiday, tender shall be opened on next working day without further intimation.

- Clarification of bids shall only be allowed in accordance with PPRA Rule 2004 Rule 31.
- 6. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank, in shape of CDR/SDR or Bonds from insurance company, having minimum AA rating.
