OFFICE ACCOMMODATION WILL HAVE FOLLOWING FEATURES:

- Office Accommodation should be in the vicinity of Gilgit area.
- Offered space measuring minimum covered area 5600 Sqft and space should be in the shape of hall with one room along with public and staff washrooms.
- Prominent, having independent entrance and not in residential area.
- Ramp for wheel chair for disable citizens.
- Government Departments will be given preference.
- Tenancy for a longer period (preferably ten years or more)
- Other details are given in bidding documents

The Envelopes shall be clearly marked as Technical/General and Financial proposals. Technical/General proposal will be **opened by 21**st **June 2022 at 1200 hours** in presence of available bidders. Proposals must include the following documents in addition to any other information that the bidder may find necessary:

- Photocopy of ownership/lease property documents.
- Photocopy of valid approved site plan & CNIC of owner
- Photocopy of NTN, GST & SST (if applicable)
- Undertaking on Non-judicial stamp paper of Rs.100/- certifying that owner / building is not temporary / permanently debarred from any Government agency / authority / department (without bearing any responsibility on NADRA whatsoever in this regard).
- Fitness Certificate
- > Offer documents received after submission of due date/time mentioned above will not be entertained.
- > Quoted price shall be inclusive of all taxes except GST / SST which shall be mentioned separately (if applicable).
- > No brokerage / service charges will be paid in case of real estate agent.
