TERMS AND CONDITIONS

- 1 No tender shall be sold / issued on the date of opening of tenders and in case of public holiday, the received and opening of tender will be the next working day.
- 2 Tender documents can be purchased on production of proof of being Proprietor of the firm or their authorized representative possessing valid power of attorney duly registered with the concerned Registrar for specific work.
- 3 The tender documents shall be issued only to the firm / contractor having valid Registration with PEC for the year 2021-22 in relevant field of specialization / Category.
- 4 The documents of the firm CNIC, NTN (ATL) valid Pakistan Engineering Council Registration for the year 2021-22 etc (Original) should be available with the applicant for purchase of tender, failing which tender will not be issued.
- 5 Call Deposit Receipt (CDR) on A/c of Earnest Money from the firm's own bank account clearly mentioning the firm name in favour of the Executive Engineer, Central Civil Division Pak. PWD Multan duly issued by any Schedule bank of Pakistan must be attached with the technical proposal.
- 6 The specification of work may be seen in Office of the undersigned on any working day during office hours.
- 7 If the contractor disfigure / disrupt his tenders, his Call Deposit Receipt will be forfeited in favour of the Government of Pakistan besides punitive action as per Rules
- 8 The Technical Proposal and Financial Proposal will be enveloped separately by marking in bold and legible letters to avoid confusion and both are then placed in a single envelope.
- 9 The technical proposals will be opened on Scheduled date i.e. 18.06.2022 at 02:00 P.M and the date of Opening of Financial Proposals will be communicated thereafter to the firms whose technical proposals declared Successful.

- 10 Criteria for evaluation of technical proposal is given in Tender Documents.
- 11 If the bid amount of successful bidder is seriously unbalance in relation to the Detailed Estimate, the bidder shall have to furnish additional Performance Security equal to the difference of Estimated Cost and the total bid amount in the shape of Bank Guarantee duly issued by any Scheduled Bank of Pakistan or Insurance Bond duly issued by an Insurance Company possessing "AA" Rating as per satisfaction of the Employer besides furnishing detailed price analysis to demonstrate internal consistency of his rates as per Clause IB.28.4 of bidding document.
- 12 Tenders with Cutting or overwriting on the rates (if any) will not be entertained & will be declared as non responsive at first stance.
- 13 No conditional Tender will be entertained at all.
- 14 Bid validity period will be 90 days.
