## **RE-INVITATION FOR e-BIDS**

National Highway Authority (NHA) Re-invites e-bids from eligible constructors, registered with income tax department and who are on Active Taxpayers List of the Federal Board of Revenue, having valid PEC registration in category C-5 with specialization in CE-01 & CE-10 for the following Routine Maintenance & Routine Maintenance (Patrolling) Works (F.Y. 2020-21) of Maintenance Region M-4 as per details mentioned below:-

- 2. The bidding shall be done through NHA e-Bidding System. Constructors, having valid PEC registration are required to create their "On-line User Account" for participation in the bidding of Maintenance Works. User Guide, illustrating the steps to create "On-line User Account", is available at <a href="www.ebidding.nha.gov.pk">www.ebidding.nha.gov.pk</a>. Access to 'NHA e-bidding system' for bidding, will be granted upon submission of pre-requisite documents as per guide line. Bid submitted, by using NHA e-bidding system, will only be considered, whereas other bids will be rejected.
- 3. Complete set of bidding documents for the above mentioned Works, containing detailed terms & conditions, method of procurement (Single Stage Two Envelope procedure), submission of e-Bids, Bid Security, bid validity, opening of e-Bid, Evaluation Criteria, etc. will be available on NHA website on **June 11, 2022** for downloading free of cost. Bidders are also advised to follow the NHA website for updates of bidding schedule and addendum(s), if any.

- 4. The e-bid must be prepared and submitted through NHA e-Bidding system in accordance with the instructions contained in the bidding documents. Hard copy of e-Bid prepared through NHA e-Bidding system, must reach at the address mentioned below on or before **June 21, 2022 till 1100 Hours**. Technical e-Bids (submitted through NHA e-Bidding system) and envelope containing hard copy of Technical e-Bid, will be opened on the same day at **1130 Hours**.
- 5. Financial Bids of qualified bidders will be opened in sequence and any firm declared lowest evaluated bidder in Two (02) RM & RM(P) contracts of F.Y 2020-21, its further financial bids will not be opened and the firm will not be considered for award of more than Two (02) subsequent RM & RM(P) Works of F.Y 2020-21.
- 6. The Firms/Bidders who have already declared lowest evaluated bidder in 02 Nos RM & RM(P) Contracts published vide PID(1)6057/21 and Price Bids opened on 11.05.2022 will not be considered for RM & RM(P) Works.
- 7. The bidders providing unsubstantiated and/or incorrect information shall be liable to disqualification and/or legal action.
