FOR PURCHASE OF MACHINERY AND HARDWARE ITEMS

Directorate General of Training and Research (Customs), Karachi invites sealed tenders from well reputed and GST registered firms, for Purchase of Machinery and Hardware Items as per Tender Documents, contractors should note the following:

- 1) Tender document may be obtained upon payment of Rs. 1,500/- non-refundable during working hours (1000 hrs to 1600 hrs) from the office of the Cashier / Head Clerk.
- 2) Quotations should include all applicable taxes. Rates quoted without taxes shall not be considered and such bids shall be liable to be rejected.
- 3) Quotations shall be **compared Item-wise**.
- 4) No over-writing in the offered prices shall be acceptable. Such bids shall be liable to be rejected.
- 5) Bidders are required to submit "Earnest Money" (equal to 2% of total quoted value), in the form of pay-order / draft, in favour of 'Pakistan Customs Academy, Karachi'
- 6) Earnest money of the unsuccessful bidders will be returned / refunded at the earliest.
- 7) Bidders are required to provide: (a) Earnest Money (b) Copy of Sales-tax Registration Certificate (c) Copy of NTN Certificate (d) Brief profile of the company (e) Where supplied in last 6 months (f) Where registered (g) Explain if defaulted / black-listed at any stage, including the current status.
- 8) Submission of false statement / documents and concealment of any information by the bidders will lead to their disqualification / black listing.
- 9) The competent authority may reject all bids at any time prior to the acceptance of a bid. The competent authority upon request may communicate to any bidder who submitted a bid, the grounds for rejection of his / her bid.

Sealed quotations along with Earnest Money (2% of the quoted value) should reach undersigned latest by **21st June, 2022** by 10:00 hours. Bids shall be opened on the same day by 15:00 hours in the presence of the bidders or their authorized representatives.
