

Sealed tenders are on percentage rate basis (NOT ON INDIVIDUAL ITEMS) are hereby invited for the works mentioned below from the approved / registered Contractors enlisted in Pak PWD in relevant category duly renewed for the current financial year 2021-22. The Tender should reach the office of the undersigned upto 11:00-AM on or before 20/06/2022, the tenders will be opened on same date at 11:30-AM in the presence of the bidders or their authorized representative who may care to attend. The tender documents and other details / information can be purchased / seen in the office of the undersigned on any working day before 20/06/2022, during working hours on payment of tender cost (Non-Refundable) as mentioned below: The following instructions may be read and understood carefully in true letter and spirit, as in case of violation of any of these, the tender forms will not be issued. The documents under mentioned must be accompanied with the application, failing which no tender's forms will be issued.

TERMS & CONDITIONS.

- 1) Copy of National Identity Card (original must be provided at the time of submission of application).
- 2) Copy of Income tax registration Certificate (NTN). The firm must be an active tax payers at ATL.(proof must be provided from FBR), non-active firm will not be entertained.
- 3) Original copy of Pak PWD Enlistment (whichever is applicable) registered in the relevant category & financial limit along with attested photocopy.
- 4) Application should be written on pad duly signed with date.
- 5) The Contractor himself will come for application regarding issuance of tender form in case of partnership, only the persons mentioned in the partnership deed / form -it will be allowed. No proxy will be allowed to participate in the building process. No authorization /attorney of any person will be accepted.
- 6) The application must be accompanied with Bid Security @ 4% of the estimated cost in shape of CDR/Call deposit form any scheduled bank of Pakistan in the name of Executive Engineer, Central Civil Division, Pak. PWD, Bannu, clearly mentioning the name of firm. The remaining Bid security @4% of the Bid amount i.e excluding the earlier one and difference between Bid amount and NIT amount must be enclosed in the sealed bid
- 7) No tender will be entertained without having bid security @ 4% of bid amount, if found, will be declared as non-responsive bid.
- 8) No pay order / Demand draft will be accepted.
- 9) The CDR must have a date of issuance after invitation of Tender notice in newspaper and on or before tender opening .No CDR having a date of issuance prior to invitation of tender will be accepted.
- 10) In case of quoting rates below than the NIT amount bidder will have to provide additional CDR equal to 10% of the NIT amount for the respective work from Schedule Bank of Pakistan in favor of Executive Engineer, Central civil Division, Pak. PWD, Bannu, (must be enclosed in the sealed envelope containing bid).in case of failure, and if the same not found in the sealed bid at the time of opening, the bid will be considered as non-responsive and will be rejected.
- 11) No tender will be sold / issued on the date of opening of tenders and in case of public holiday, the opening of tenders will be the next working day.
- 12) No tender will be issued / received thorough post, telegraph or E-Mail.
- 13) According to PPRA Rule-25, Bid Security @ 2 % of estimated cost in the shape of CDR/Call deposit from any scheduled Bank in the name of the Executive Engineer, Central Civil Division, Pak PWD, Bannu. Tenders can be purchased on the prescribed cost (Non-refundable) in Cash mentioned against the below noted work from the office of the undersigned during office hours upto 20/06/2022 before the date of opening of tenders.
- 14) All CDRs once received will be credited into the Government Account and will be refunded through Government Cheque.
- 15) 1st, 2nd, 3rd, lowest bidders CDR will be retained till acceptance of tender.
- 16) In case of tie, the tender will be decide on technical and financial evaluation basis on date of opening of tender.
- 17) The bidder will be required to give a detailed analysis of workability of his bid if deemed necessary.
- 18) The documents provided by the bidders if found ambiguous will be verified and in case of fake one, the firm will face immediate / appropriate penal action as per rules and law.

- 20) Under Rule 33(1) of public Procurement Rules, 2004, the competent authority reserves the right to reject all bids or proposals at any time prior to the acceptance of bid or proposal.
