The bidder shall be screened out in the preliminary checking subject to not fulfillment of all conditions, rendered as under:

- 1. PEC valid registration for CFY.
- 2. PEC relevant Category and Code i.e CE-10, CE09.
- 3. NOC "No Sick Project" from Works Secretariat.
- 4. CNIC of the Prospective bidder / firm.
- 5. Certificate of (No Court Case / Litigation with Works Department).
- 6. Signature of bidder / witness on bidding documents is mandatory.
- 7. Required bid security amount by a scheduled bank of Pakistan (1B:15.3)
- 8. Signing of integrity pact. Non-influencing the bidding process (PPRA Rule).
- 9. Late submission of bid will not be entertained.

Ts &Cs.

- 1. Complete set of tender with detailed criteria for qualification and evaluation, BOQ and specifications can be obtained from office of the Executive Engineer/the Secretary of the procurement committee upon cash payment on request through application on any working day for buying of the documents during office hours.
- 2. The bidder should have requisite category and above codes mentioned therein, that shall be checked through fresh download from PEC website by the committee.

- 3. The bid security @ 2% of Engineers cost estimate in form of Deposit at Call or Bank Guarantee issued by a scheduled bank in Pakistan duly accompanied with the TB/Bid in the name of XEN concerned valid for a period of 28 days beyond the bid validity period.
- 4. Conditional / telegraphic tenders shall not be accepted Pre-bid meeting shall be called 07 days prior opening of bid subject to submission of queries by prospective bidders if required.
- 5. Any tenders with omission / overwriting shall be rejected.
- 6. All taxes shall be deducted as per prevailing rules of GoGB.
- 7. Tenders documents shall only be issued to the bidders or their authorized representation on production of his/her original CNIC / Renewal fee receipt 2021-22 having valid registered power of attorney in original.
- 8. In case of firms/company /joint venture, registered power of attorney and partnership deed in original must be produced for issuance of tender documents.
- In case of JV, cumulative score of partners shall be taken into account only when both or all have requisite category and above only.
- 10. Bid discount in accordance PPRA Rule 2004, 38(A) shall be considered.
- 11. The successful bidder shall provide performance guarantee @ Rs. 10% of bid amount from any schedule bank or Insurance Company 'AA' rating after approval of rates within 28 days. However in case of unbalanced bid tender below 10% of the T/S cost the bidders shall deposit CDR from any schedule bank @ Rs. 50% of differential amount calculated below 10% of T/S cost within 14 days of letter issued by the Engineer prior to acceptance letter. Bidders' fails to deposit the CDR from any schedule bank within given time their bid security shall be forfeited.
- 12. The employer reserves the right to accept or reject any bid and the bidding process and reject all bids with reasons thereof (if any).
- 13. In case of any deviation, conflict in bidding procedure the provision of PEC & PPRA Rule 2004 shall prevail. The appealing authority shall be the one whom rested the power of bid acceptance.
- 14. The application must be received in the office of the Executive Engineer B&R Division GB PWD Shigar near Rest House Hospital Road on or before 21st June 2022. Application received after due date will not be entertained.
- 15. All terms and conditions of procurement processes guidelines (QnE Criteria) issued by Works Secretariat vide No. Sec-SO-D-9(28)2020-21/3831 dated 15th December 2020, and PEC Bidding document shall be part of procurement.
