**MANDATORY CONDITIONS:-**

- Applications for receiving bidding documents should be on original letter pad of the contractor with signature.
- Registration with PEC for CFY (2021-22) with relevant code and category for each works.
- Renewal receipt GB-PWD for CFY (2021-22).
- No Sick Project in hand (will conformed from Works Secretariat)/affidavit by the contractor.
- CNIC of the Prospective bidder/firm.
- Certificate of No Court Case/Litigation regarding delayed/ sick project with Works Department and Water & Power Department GB.

**TERMS & CONDITIONS:-**

- The bidding documents will be issued to firm/contractors subject to production of 2% bid security in shape of CDR issued by any schedule bank in Pakistan and upon production of his/her original CNIC, renewal fee for CFY and Original PEC licence.
- All terms and condition of procurement process guidelines issued by Works Secretariat vide Notification No. Sec-SO-D-9(28)/2020/5271 dated 27<sup>th</sup> October, 2021 and PEC bidding document shall be part of procurement.
- Rates quoted more than 20% below T/S Shall be rejected straight away and for rates quoted in between 10% to 20% the most advantageous bidders shall have to deposit additional 75% of difference amount from T/S as performance guarantee within next five working days.
- No bid shall be accepted beyond closing time as mentioned against each work.
- In case of Gazette holiday/local holiday, tender shall be opened on next working day without further intimation.
- The Bid validity will be 90 days after the date of opening of the bid.
- Clarification of bids shall only be allowed in accordance with PPRA Rule 2004 Rule 31.
- Overwriting on bidding document is not allowed and in case of any overwriting/omission is found the bid shall be rejected.
- The subletting of contract, if any shall be filled in the given format in the bidding document and same shall be made part of contract agreement, otherwise subletting shall not be allowed.



11. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank having AA rating insurance company.

In case of any conflict, PPRA Rule 2004 amended in 2021 and clauses of PEC Standard Bidding Documents, Planning Commission project manual, Public finance management Act, 2019 shall prevail, in any case PPRA Rule 2004 shall be major rule having overriding effect on all rules concerning procurement.
13. Bids shall be opened in the office of the Executive Engineer B&R Division Ghanche by the procurement committee comprising of the XEN, SDO concerned, Head Estimator.
