Note: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Firms / Contractors not borne on approved list of MES will furnish their applications along with statement of previous experience, giving details of works executed during last two years and those in hand, on proforma appended below:-
