#### **MANDATORY CONDITION:** (A)

- PEC valid Registration for CFY with relevant category and code. i.
- Latest profile of the constructors/firm/JV from PEC website. ii.
- Renewal receipt GB-PWD for CFY (2022-23). iii.
- NOC for no Sick Project in hand from Works Secretariat)/affidavit by the contractor iv.
- CNIC of the Prospective bidder/firm/JV. ٧.
- Certificate in the form of Affidavit of No delayed project/ Court Case/Litigation with vi. Works Department and Water & Power Department GB
- Bid security as specified in shape of CDR from any scheduled bank. vii.
- Constructor/firms/JV must have a bank transaction for last one year of at least 20% of the viii. value of the project cost or have bank credit line of at least 50% of the project cost.
- In case of JV agreement, it should be executed on proper format duly signed by both ix. partners of JV clearly mentioning share of each partner and lead partner duly attested by Magistrate 1st class. Both JV members should have the required category and codes. Number of JV members shall not be more than two. The principal to associate ratio shall not be less than 60:40 respectively. Principal member should get 50% minimum marks and associate member should score 30% minimum marks in each category and overall cumulative marks should be minimum 60%.
- Only one bid will be entertained either as single bidder or JV partner. x.
- Bank statement should be properly stamped and signed by the concerned Bank Manager. xi.
- The Qualification and Evaluation Criteria is enclosed with the bidding documents. Al xii. bidders are directed to fill the form duly certified on an affidavit on a judicial stamp paper of Rs. 100.

#### Ts & Cs **(B)**

- The call deposit in shape of CDR provided by the bidder along with bid will be verified from 3. the relevant bank prior to acceptance of the technical bid by the concerned authority, bid security shall be as specified in the NIT.
- The pre-bid meeting will be held in the office of the Chairman bid Evaluation committee/ 4. Superintending Engineer GB PWD Skardu/Shigar Circle Skardu on 18<sup>th</sup> July, 2022 at 02:00 PM.
- No bid shall be accepted beyond closing of time as mentioned against each work 5.
- In case of any deviation, conflict in bidding procedure the provision of PEC & PPRA Rule, 2004 6. shall prevail
- All terms and condition of procurement process will be in accordance with guidelines issued 7. by Works Secretariat vide Notification No. Sec-SO-D-9(28)/2020/5271 dated 27th October, 2021 and PEC bidding documents.
- Rates quoted below 10% upto 20% of T/S amount, the advantageous bidder shall have to 8. deposit additional performance guarantee@ 75% of difference amount calculated below 10% of T/S cost within (05 days) five working days, in shape of CDR from any Schedule Bank of Pakistan.
- In case of local holiday bid will be opened on next working day without further intimation. 9.
- Overwriting on bidding document is not allowed and in case of any overwriting/omission is 10. found the bid shall be rejected.
- The subletting of contract, if any shall be filled in the given format in the bidding document 11. and same shall be made part of contract agreement (CA), otherwise subletting shall not be allowed.
- Technical and financial bids shall be opened by the procurement committee constituted by 12. Works Secretariat.
- Signing of all pages of Bidding documents, integrity pact (on stamp paper duly signed) and 13. self-evaluation checklist shall be mandatory, failing which the bid shall be treated as nonresponsive and summarily be rejected in the initial screening phase.

- 14. In case of any conflict, PPRA Rule 2004 amended in 2021 and clauses of PEC Standard Bidding Documents, Planning Commission project manual, Public finance management Act, 2019 shall prevail, in any case PPRA Rule 2004 shall be major rule having over riding effect on all rules concerning procurement.
- 15. Clarification of bids shall only be allowed in accordance with PPRA Rule 2004 Rule 31 and Standard Bidding Documents relevant clauses.
- 16. Performance guarantee shall be @ 10% of the contract amount from any scheduled bank or AA rating insurance company.
- 17. Bids shall be opened in the Office of the Chairman bid Evaluation committee/ Superintending Engineer Skardu/Shigar Circle.
