ELIGITBILITY

- **3.** This Invitation for Bids is open to all Bidders complying the following requirements: Written request accompanied with copies of: -
- a) Pakistan Engineering Council valid certificate for Year 2021-22 with Category C-4 having Specialization Code CE-10, CE-02 & EE-05 must be provided.
- b) The bidder should have sound financial status. The difference between current assets and short term liabilities should be positive. Minimum average annual construction turnover calculated as total certified payments received for contracts in progress or completed, within the last three (3) years equal to or more than the bid price.
- Participation in at least one or two contracts that have been successfully completed within the last ten (10) years and that are similar to the proposed scope of work (Pole foundations, erection of poles, stringing, testing & commissioning), where the value of the Bidder's participation exceeds PKR 80 Million in one or two contracts (The bidder will submit completion certificate of the projects).
- d) In case of JV, all the JV partners shall jointly meet the requisite criteria with the lead partner or other partner(s) meeting not less than 40% and 25% respectively of the said criteria.
- e) The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- f) Identity Card of Contractor / Managing Partner / Director of the firm.
- g) Bidding documents will be issued only to the owner of the firm OR representative holding authority letter of the firm.
