- 2. If Rates quoted below 10% upto 20% of T/S amount, the advantageous bidder shall have to deposit additional performance guarantee @ 75% of difference amount calculated below 10% of T/S cost within (05) five working days, in shape of CDR from any Schedule Bank of Pakistan.

3. No bid shall be accepted beyond closing time as mentioned against each work.

- In case of local holiday, tender shall be opened on next working day without further 4. intimation.
- 5. Clarification of bids shall only be allowed in accordance with PPRA Rule 2004 Rule 31.
