2. Open competitive Bidding will be carried out by adopting <u>"Single Stage</u> <u>Two Envelope"</u> procedure. Bidders are required to be registered with Pakistan Engineering Council in <u>Category C-5</u> or above for the Year 2021/2022, having specialization Code as indicated in table above. The Firm(s) can also apply in Joint Venture (JV) to other firms. However, PEC Registration for all the JV partners and <u>100% qualification of One Firm</u> as per NIT/Bidding Documents is mandatory.

3. Bidders can download bidding documents from NHA Website. The bidders are advised to visit the site before submission of bids. For any additional information, the interested bidders may contact the office of General Manager (Maintenance) GB, NHA Gilgit before the bid submission date within office hours. Bidders representatives would be required to present the **"Authority to submit the Bid"** while submitting the bids.

4. Bids shall be received on or before <u>25<sup>th</sup> July, 2022</u> upto <u>1100 Hours</u> in the office of the General Manager (GB), NHA Office Complex, Heli Chowk, Jutial Cantt., Gilgit. The Bidder shall submit **two (2) sets of Technical Proposal** (one original and one duplicate copy in sealed envelope), against each Contract tabulated above. *(If a contractor applies for all contracts than at least one original technical proposal is mandatory among the all*). Each page of the technical proposal shall be numbered, signed and stamped by the bidder, as mentioned in the Checklist. Incomplete Bidding Documents shall be considered non-responsive and rejected accordingly. 5. The envelope containing **"Original Technical Bid"** will be opened on the same day at <u>**1130 hours**</u> in the presence of bidder's representatives who may choose to attend, whereas the duplicate copy of the Technical & Financial Bid shall be kept sealed. Sealed Envelope containing **"Financial Bid"** of technically qualified bidder(s) will be opened later, the date of which will be communicated after evaluation of the Technical Bids.

6. Bidders are required to possess relevant experience of satisfactory completion of minimum Two (02) Contracts of similar nature and complexity as contractor or management contractor (but not as sub-contractor) with minimum **value of 50% of the Engineer's Estimate for each during last seven (07) years**. Copies of Letter of Acceptance, Award, Commencement, Contract Agreement, BOQs and Completion Certificate of similar contracts **<u>must be provided</u>**.

7. Bid Security of an amount mentioned in Bidding Data Sheet, in the form and validity as mentioned in the bidding documents, must be accompanied with "**Technical Bid**". Bidders are required to submit their bid strictly in accordance with the conditions of bidding documents.

8. The bidders are required to provide the following **<u>mandatory</u>** certificates on Judicial Stamp Paper separately, duly attested by the Oath Commissioner/ Notary Public:-

- a. Pending Litigation/No Litigation/Non-Blacklisting Certificate;
- b. Minimum Professional Staff (as mentioned in the bidding documents) along with CVs and Undertaking that the staff will be available for execution of work at site; and
- c. Minimum Equipment/Machinery (as mentioned in the bidding documents) for execution of work at site.
- d. Audit reports for last 3 years duly verified by concerned auditors registered with ICAP Directory.

9. The firms providing incomplete, unsubstantiated and/or incorrect information are liable to disqualification and/or legal action. NHA reserves the right to reject any bid or all bids as per the PPRA Rule No. 33(1).
